BIOSECURITY ACT 2008

**Extension of Declaration of Biosecurity Emergency
Areas for Bovine Tuberculosis
(*Mycobacterium bovis*)**

In exercise of the powers conferred on me by section 77 of the Biosecurity Act 2008, with the advice of the Biosecurity Authority of Fiji and in consultation with the National Disaster Management Council, I hereby extend the declaration of the biosecurity emergency areas for Bovine Tuberculosis (*Mycobacterium bovis*) published in Legal Notice No. 71 of 2018 for the whole of Fiji.

This Declaration is in force for a period of 6 months from the date of its publication in the Gazette.

Any movement of cattle and calves within Fiji is strictly prohibited unless the Biosecurity Authority of Fiji provides prior authorisation for the movement.

Pursuant to sections 79(3) and 94 of the Biosecurity Act 2008, any person who contravenes any direction made pursuant to this Declaration commits an offence and is liable to the penalties prescribed under Schedule 5 to the Biosecurity Act 2008.

BIOSECURITY ACT 2008

**Extension of Declaration of Biosecurity Emergency
Areas for Giant Invasive Iguana/Green Iguana
(*Iguana iguana*)**

In exercise of the powers conferred on me by section 77 of the Biosecurity Act 2008, with the advice of the Biosecurity Authority of Fiji and in consultation with the National Disaster Management Council, I hereby extend the declaration of the biosecurity emergency areas

for Giant Invasive Iguana/Green Iguana (*Iguana iguana*) published in Legal Notice No. 72 of 2018 for the Savusavu area and the whole islands of Qamea, Matagi, Taveuni, Laucala, Viubani and other surrounding islets.

This Declaration is in force for a period of 6 months from the date of its publication in the Gazette.

Any movement of all stages of the Giant Invasive Iguana/Green Iguana (*Iguana iguana*) including eggs within, into and out of the declared biosecurity emergency areas is strictly prohibited.

Pursuant to sections 79(3) and 94 of the Biosecurity Act 2008, any person who contravenes any direction made pursuant to this Declaration commits an offence and is liable to the penalties prescribed under Schedule 5 to the Biosecurity Act 2008.

BIOSECURITY ACT 2008

**Extension of Declaration of Biosecurity Emergency
Areas for Bovine Brucellosis
(*Brucella abortus*)**

IN exercise of the powers conferred on me by section 77 of the Biosecurity Act 2008, with the advice of the Biosecurity Authority of Fiji and in consultation with the National Disaster Management Council, I hereby extend the declaration of the biosecurity emergency areas for Bovine Brucellosis (*Brucella abortus*) in Legal Notice No. 73 of 2018 for the whole of Fiji.

This Declaration is in force for a period of 6 months from the date of its publication in the Gazette.

Any movement of cattle and calves within Fiji is strictly prohibited unless the Biosecurity Authority of Fiji provides prior authorisation for the movement.

Pursuant to sections 79(3) and 94 of the Biosecurity Act 2008, any person who contravenes any direction made pursuant to this Declaration commits an offence and is liable to the penalties prescribed under Schedule 5 to the Biosecurity Act 2008.

BIOSECURITY ACT 2008

**Extension of Declaration of Biosecurity Emergency
Areas for Asian Subterranean Termites
(*Coptotermes gestroi*)**

IN exercise of the powers conferred on me by section 77 of the Biosecurity Act 2008, with the advice of the Biosecurity Authority of Fiji and in consultation with the National Disaster Management Council, I hereby extend the declaration of biosecurity emergency areas for Asian Subterranean Termites (*Coptotermes gestroi*) published in Legal Notice No. 75 of 2018, for the areas of Lautoka (17° 37' 16.3056" S, 177° 26' 54.0924" E) and Labasa (179° 23' 4.1208" E, 16° 25' 10.8" S) as identified in the Schedule to this Declaration.

This Declaration is in force for a period of 6 months from the date of its publication in the Gazette.

Any movement of all stages of the Asian Subterranean Termites (*Coptotermes gestroi*) including eggs within or out of the declared biosecurity emergency area is strictly prohibited.

Any movement of any material hosting the Asian Subterranean Termites (*Coptotermes gestroi*) within or out of the declared biosecurity emergency areas is strictly prohibited unless the Biosecurity Authority of Fiji provides prior authorisation for the movement. Host material includes the Asian Subterranean Termites (*Coptotermes gestroi*) nests, soil, potted plants, wood, logs, timber, lumber, kindling, planks, wooden building materials, wooden furniture, live plants, harvested host plants (pine, mango, cassava, coconut tree and sugarcane) and articles made of cellulose (books, papers, clothing, and textiles).

Pursuant to sections 79(3) and 94 of the Biosecurity Act 2008, any person who contravenes any direction made pursuant to this Declaration commits an offence and is liable to the penalties prescribed under Schedule 5 to the Biosecurity Act 2008.

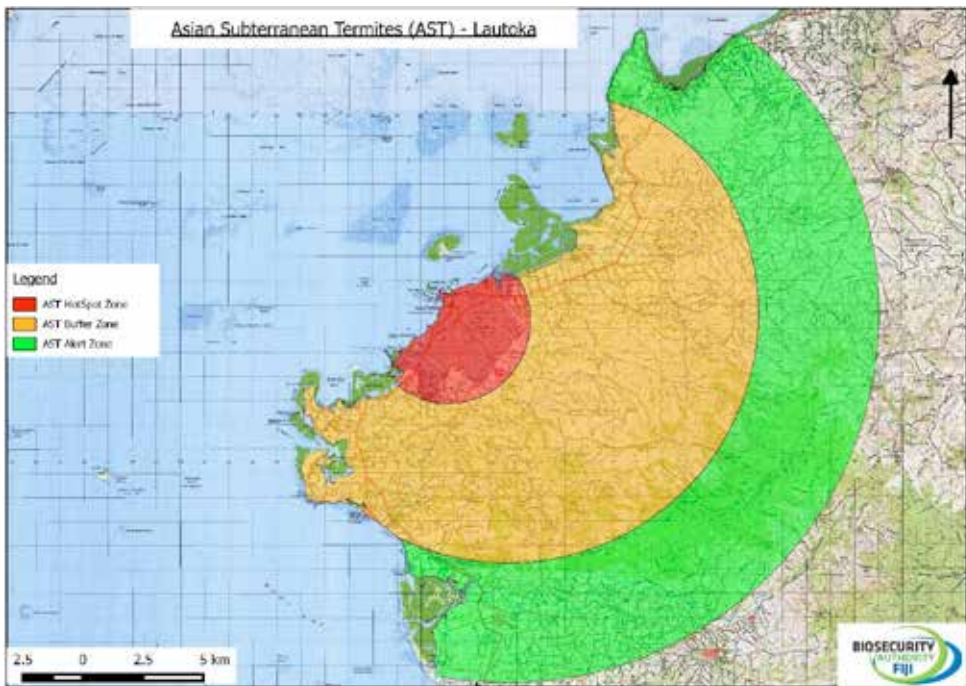

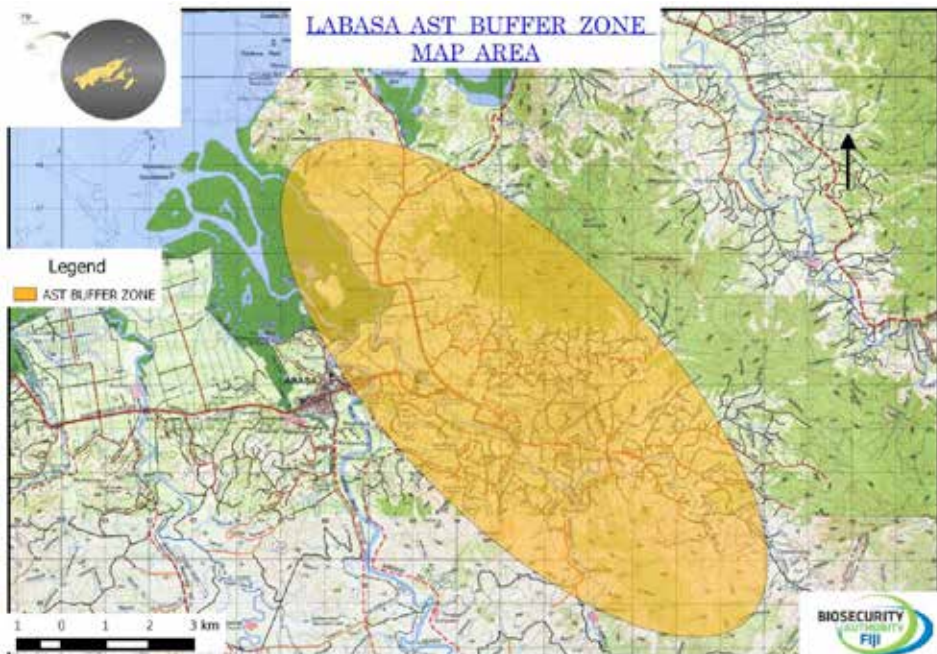
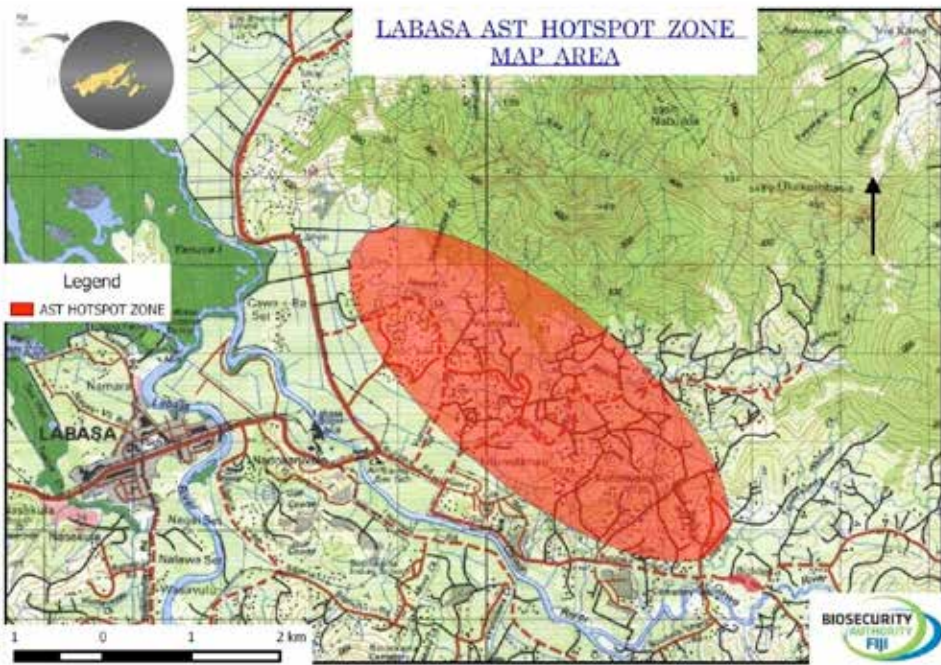
ASIAN SUBTERRANEAN TERMITES (*Coptotermes gestroi*) INFESTED ZONES

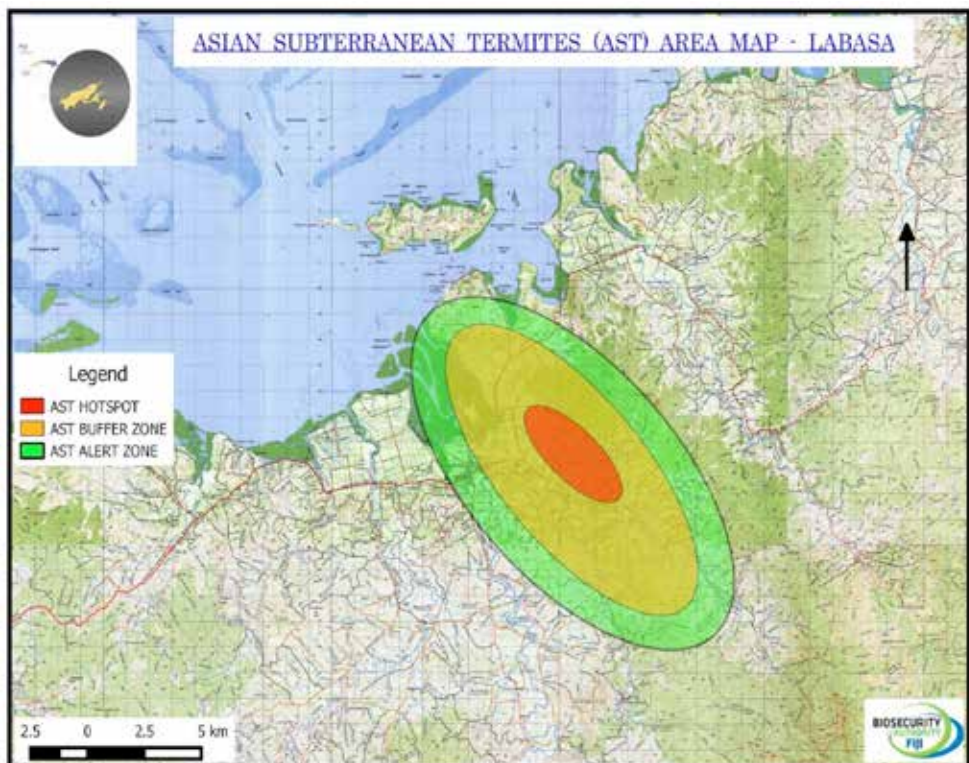
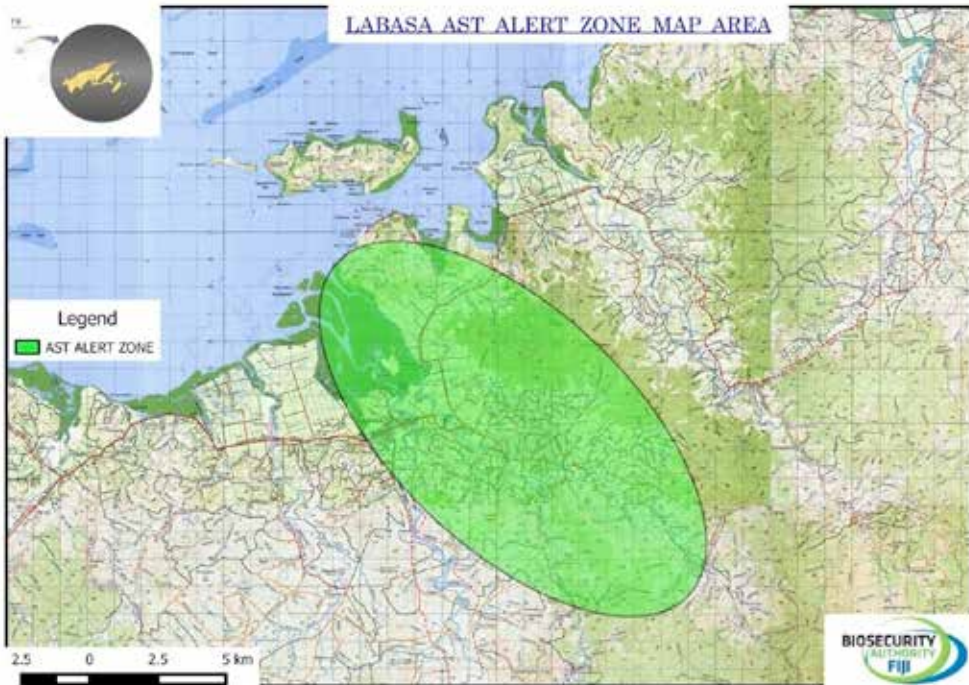
PART 1 - INFESTED ZONES IN VITI LEVU

BIOSECURITY ACT 2008

**Declaration of Biosecurity Emergency Areas for
American Foulbrood
(*Paenibacillus larvae*)**

IN exercise of the powers conferred on me by section 77 of the Biosecurity Act 2008, with the advice of the Biosecurity Authority of Fiji and in consultation with the National Disaster Management Council, I hereby declare the whole of Fiji as a biosecurity emergency area for American Foulbrood (*Paenibacillus larvae*).

This Declaration is in force for a period of 6 months from the date of its publication in the Gazette.

Any movement of honey bees, bee hives and bee products within Fiji is strictly prohibited unless the Biosecurity Authority of Fiji provides prior authorisation for the movement.

Any movement of any material such as bee keeping tools and equipment exposed or having any type of contact with honey bees within Fiji is strictly prohibited unless the Biosecurity Authority of Fiji provides prior authorisation for the movement.

Pursuant to sections 79(3) and 94 of the Biosecurity Act 2008, any person who contravenes any direction made pursuant to this Declaration commits an offence and is liable to the penalties prescribed under Schedule 5 to the Biosecurity Act 2008.

BIOSECURITY ACT 2008

**Declaration of Biosecurity Emergency Areas for
Fruit Fly Species
(*Bactrocera kirki* and *Bactrocera obscura*)**

IN exercise of the powers conferred on me by section 77 of the Biosecurity Act 2008, with the advice of the Biosecurity Authority of Fiji and in consultation with the National Disaster Management Council, I hereby declare the whole of Rotuma to be a biosecurity emergency area for the fruit fly species (*Bactrocera kirki* and *Bactrocera obscura*).

This Declaration is in force for a period of 6 months from the date of its publication in the Gazette.

Any movement of all stages of the fruit fly species (*Bactrocera kirki* and *Bactrocera obscura*) including eggs, larvae and pupa, or of any material hosting the fruit fly species (*Bactrocera kirki* and *Bactrocera obscura*), out of the declared biosecurity emergency area is strictly prohibited. Host material include all fruits found in Rotuma.

Pursuant to sections 79(3) and 94 of the Biosecurity Act 2008, any person who contravenes any direction made pursuant to this Declaration commits an offence and is liable to the penalties prescribed under Schedule 5 of the Biosecurity Act 2008.

BIOSECURITY ACT 2008

**Declaration of Biosecurity Emergency Areas for
Varroa Mite
(*Varroa jacobsoni*)**

IN exercise of the powers conferred on me by section 77 of the Biosecurity Act 2008, with the advice of the Biosecurity Authority of Fiji and in consultation with the National Disaster Management Council, I hereby declare the whole of Fiji as a biosecurity emergency area for Varroa Mite (*Varroa jacobsoni*).

This Declaration is in force for a period of 6 months from the date of its publication in the Gazette.

Any movement of beehives, nucleus colonies, queen bees or used apicultural equipment within Fiji is strictly prohibited unless the Biosecurity Authority of Fiji provides prior authorisation for the movement.

Pursuant to sections 79(3) and 94 of the Biosecurity Act 2008, any person who contravenes any direction made pursuant to this Declaration commits an offence and is liable to the penalties prescribed under Schedule 5 to the Biosecurity Act 2008.

INTERPRETATION ACT 1967

Rectification of Errors Order 2019

Short title and commencement

1. This Order may be cited as the Rectification of Errors Order 2019.
