# **Online Safety Regulations 2019**

IN exercise of the powers conferred on me by section 28 of the Online Safety Act 2018, I hereby make these Regulations—

Short title and commencement

- 1.—(1) These Regulations may be cited as the Online Safety Regulations 2019.
- (2) These Regulations come into force on the date of publication in the Gazette.

#### Immediate family member

2. For the purposes of section 10(2) of the Act, an immediate family member includes an individual's stepfather, stepmother, grandfather, grandmother, grandson, granddaughter, stepson, stepdaughter, brother, sister, half-brother and half-sister.

#### **Complaints**

- 3.—(1) Any complaint lodged under section 13 of the Act must be made in the form prescribed in the Schedule.
- (2) A complaint made in the prescribed form may be hand delivered to the Commission or sent to the Commission by post or electronic mail or through an approved online portal.
- (3) The Commission may amend the form prescribed in the Schedule as it deems necessary.
- (4) For the avoidance of doubt, the provisions of the False Information Act 2016 apply in relation to any information provided to the Commission.
