 - (2) These Regulations come into force on the date of publication in the Gazette.
- (3) In these Regulations, the Fijian Competition and Consumer Commission Act 2010 is referred to as the "Act".

Requisition for Information Notice

- 2.—(1) In accordance with section 119 of the Act, the Fijian Competition and Consumer Commission may issue a Requisition for Information Notice to a person to obtain information from that person for the purposes of the Act.
 - (2) The Requisition for Information Notice is set out in the Schedule.
