Govt sets support packages for MSMEs

HE Government recently announced concessional and financial support packages for micro, small and medium enterprises (MSME) for Fijians that have been affected due to COVID-19.

These concessional packages will be available from June 7, 2020.

Attorney-General and Minister for Economy Aiyaz Sayed-Khaiyum, while announcing the package in Suva recently, said the Government will be offering micro enterprises a concessional loan of \$7,000 with a 0.5 interest rate on a five year loan term.

The A-G said that an ad-hoc organisation 'Business Assistance Fiji' comprising of accredited members from the Fiji Institute of Accountants, Fiji Chamber of Commerce and Industry, Fiji Commerce and Employers Federation, Women in Business and the MSME (under the Ministry of Commerce) will carry out assessments on eligibility.

Business Assistance Fiji will also

be able to assist newcomers to the micro-enterprises industry in meeting the necessary requirements in order to be eligible for the concessional loan.

"We recognise that there are quite a few people now who are unemployed but have very good skill sets. They will be able to utilise that," the A-G said.

For small enterprises, the Government is offering working capital of up to \$14,000 with a one per cent interest rate.

Small enterprises eligible for this

assistance will also be assessed by Business Assistance Fiji.

Repayments in this regard will not be similar to bank loans.

"We will simply set out the amount of money that they need to pay in a year and it is up to them how they carry out the repayments. As long as they are able to make repayments within one year of the amount that is stated."

For medium enterprises, the A-G announced that maximum funding eligibility of \$21,000 will be made available for them at an interest

rate of 1.5 per cent and a five year loan term with a grace period in the first year.

In addition, under a MSME credit guarantee scheme through the Reserve Bank of Fiji, the Government has announced that it will guarantee up to 60 per cent of the default amount for loans up to \$60,000.

Entrepreneurs in the agriculture, fisheries and forestry sector will also be assisted with government guarantee of up to 75 per cent of the principal outstanding on the defaulted loans of up to a limit of \$75,000 per business.

"In order to encourage women's role in driving our economic road to recovery, and to support the development of agriculture, fisheries, and forestry sector, government will now guarantee up to 75 percent with the principal outstanding on the defaulted loans up to a limit of 75,000 per business," the A-G said.

The A-G also announced that the waiting period for businesses to lodge claims will now be reduced from 180 days to 120 days.

Aust, NZ travel bubble feedback 'positive'

▲ THE travel bubble does not just mean tourism but also other types of commercial and financial opportunities being open for us considering the advantage of our hub status."

This was emphasised by the Attorney-General and Minister for Economy Aiyaz Sayed-Khaiyum while updating the Parliament on the travel bubble negotiations with Australia and New Zealand.

"We found that the talk coming out from Wellington and Canberra was that they have discussed about the Pacific being included in the bubble," the A-G said.

"The feedback so far has been very positive but as we know there is a number of issues pertaining to Australia itself as different states are treating each other differently and I think they need to be able to resolve that before New Zealand actually agrees to it," he added.

"We are very keen of course to have this travel bubble open up but as we mentioned yesterday that there will be a number of conditions that will be placed and we need to be concerned too because in comparison on the phase of it, we are much safer from the COVID-19 perspective than those two countries."

The A-G highlighted that the risks have to be managed as it has a huge impact on the Fijian economy with the inability of travel between those two countries, taking into consideration that the two countries provide nearly 70 per cent of the tourism arrivals.

"The different countries in the Pacific have different experiences pertaining to COVID-19 and different capacities pertaining to the ability to track the spread of COVID-19."

"We are the only Pacific Island country that ac-

tually has a World Health Organization certified COVID-19 testing laboratory with no fatalities to date," he stressed.

"We have to ensure that we are in the right track plus there is a huge uptake regarding the launch of the COVID-19 contact tracing programme - CareFIJI app - because it provides people with reinsurance," the A-G said.

He adds a study has come out of England that states contact tracing gives people a lot of confidence and the ability of the Ministry of Health officials to very quickly get to the contacts of people who may actually be COVID-19 posi-

tive.

"The uptake of contact tracing is critically important because a lot of countries will adopt it and we hope they do so too," the A-G said.

"Any visitor arriving into Fiji needs to upload the app which will help them to help us to be able to contain the spread of the virus really quickly in terms of the contact tracing capacity," the A-G added.

He said the extra precautions are also being taken to ensure that Fiji is included in the travel bubble and that there is no threat of COVID-19 being imported into the country.

tives like markets for change introduced to vendors by stakeholders such as the United Nations Women they are now more knowledgeable on how to be resilient and on how to address issues with market management.

"We are now confident to run our business, we are now more aware of our rights and responsibilities as market vendors."

In opening the Market, Prime Minister Vorege Bainimarama stated that when they broke ground on the new market in 2017, they saw a glimpse of the stronger and more resilient Fiji that would rise from TC Winston's devastation.

PM Bainimarama highlighted that for decades many vendors travelled for long hours to get to the market, however, with the opening of this new market this would be a thing of the past.

"With 320 stalls, 30 beds, and ample washrooms and showers, this market was designed not just as a more attractive, well-lit space for customers to shop, but as a second home for our vendors in the hours before it opens and after it closes.

"By providing a hygienic environment, reliable services and a safe place for vendors who have travelled long distances to rest their heads, this market will do more than support livelihoods — it will uplift lives."

"This market does more than grant vendors a secure night's sleep in clean facilities; it is a powerful platform for empowering Fijian women. It helps women vendors not only to start new small businesses, but tap into the full potential of their ventures through on-site training and mentoring."

"Across Fiji, we're building an entire network of modern marketplaces, including markets and mini-markets that lifts Fijian commerce to the same operating standard found in advanced economies.

"As these new facilities open, we must close the door on the old ways of informal selling. The vendors already selling within the walls of this market should be commended, the remaining vendors in the Rakiraki area must end their selling in informal stalls and make the move to this new facility. It's not safe, it's not hygienic, and it's not legal. Instead, put this market to use; it is where your business ought to run in a modern economy."

"And by formalising your livelihood into a small business, you'll also be eligible for easily-accessible government assistance, opening up new opportunities for growth that you may have never thought possible – so I urge you to seize this chance to tap into your full economic potential."

PM Bainimarama also urged all Fijians to work hand in hand in order to move the country forward.

"Our progress must press onwards. In the face of this latest crisis, our support for our vulnerable must strengthen. That is why we're working with FNPF to support impacted Fijian families in a sustainable manner that grants them stability today and without compromising their financial security, years later when they retire.

"We must look within ourselves for innovation, and look inwards within our economy for new sources of prosperity."

Sectoral approach for TC Harold assistance

TOTAL of \$3.6 million was utilised for Phase I of response to deliver immediate lifesaving emergency food and water assistance as well as non-food items.

Restoration of critical infrastructures, such as communications, water and power supply, were also initiated immediately.

This was highlighted by the Minister for Defence, National Security and Policing. Disaster Management, Rural and Maritime Development Inia Seruiratu while responding to queries on the Tropical Cyclone Harold management operations that was raised in Parliament last week.

Minister Seruiratu said those efforts were followed by Phase II of TC Harold operations which involved a second round of food, water distribution and early recovery efforts. Another \$1.2m was used for the implementation of Phase II of the TC Harold

"For the first time, Government also deployed a desalination plant to assist with the emergency water carting and at the same time, provide safe drinking water to affected communities."

"The sectoral impact of TC Harold was estimated at over FJ\$100m based on the Government's coordinated Detailed Damage Assessment (DDA) exercise that was carried out from 13th April, 2020 to 28th April, 2020. The exercise was combined with resource based preliminary rehabilitation initiatives and other sectoral recovery works."

Minister Seruiratu adds that damage to the agriculture sector has been estimated at around \$27.8m with 90 per cent of crops destroyed in the worst affected areas and much of people's subsistence crops ruined.

This is quite significant, as subsistence agriculture plays an important role in food security and the livelihoods of these Fijians.

"Based on the DDA data, a total of 2,227 houses were partially damaged and a total of 961 houses have been fully destroyed in the four Divisions, worth \$24.4m. Despite the swift response by Government in the form of tents and tarpaulins as temporary shelters, the number of affected houses is quite significant and will require a major reconstruction effort."

"For the first time, the Ministry of Forestry in partnership with the Ministry of Housing and Community Development and the National Disaster Management Office, developed a strategy to utilise salvaged logs to be considered as one-third contributions for the reconstruction of damaged homes in Kadavu and Lau.

Significant damage were also recorded for the infrastructure sector, with damage to Cicia, Koro and Moala Jetties, and a number of road slips in the Central Division."

The Water Authority of Fiji also recorded damage in the Central Division, Western and Eastern Divisions and likewise, for the energy sector. Damage to the infrastructure sector has been estimated at \$27.1m

"Our education facilities in the Central, Eastern and Western Divisions have sustained heavy damage at an estimated cost of \$10.7m."

"The fisheries and forestry sectors have also sustained damage worth \$8.1m. This is largely driven by the damage to the Kadavu and Matuku Pine Schemes and damage to fishing equipment and facilities in the fisheries sector."

Damage to community infrastructure, particularly for health facilities has been estimated at \$2.6m, disrupting the delivery of services to communities and will require quick repair or replacement, given that the restoration of such services is critical, not only for the wellness of the people but also, in terms of mitigating the risks of COV-

Rise in demand for fruit trees

THE Ministry of Forestry is continuing its effort to empower communities to establish and raise fruit trees as well as livelihood trees such as Sikeci, Tavola, and even coastal trees like Dilo and Dogo.

These trees will in turn could generate returns in a shorter time.

Speaking in Parliament during the May sitting last week, the line Minister Osea Naiqamu said people turning to backyard gardening and subsistence farming has increased the demand for fruit trees like breadfruit, ivi, tarawau, kavika, dawa, cumquat, avocado and guava among others.

"The Ministry is liaising with the Ministry of Agriculture to purchase seedlings from these communities for establishment in areas requiring food security and rehabilitation," Minister Naigamu said. "We are also working with over 150 community nurseries, and plan to establish more. I had the privilege of opening two nursery distribution centres for Rewa and

already see a bright future for the Naiqamu said. communities involved."

The Ministry of Forestry in collaboration with the Ministry of Youth and Sports has employed numerous youths to assist in nursery production and tree-planting in the Western Division and collectively they helped plant over 100,000 trees in the past four

"We are also collaborating with the Ministry of Women to actively engage women's groups in establishing nurseries where materials for building nurseries and training in raising seedlings will be provided to women and youths in both Tailevu this past Friday and can rural and urban areas," Minister

"In the midst of the pandemic, and with the assistance of the United Nations Development Programme (UNDP), the Government is coordinating a "cash for work or cash for tree-planting programme", geared especially towards the workers in the tourism industry who have lost their jobs due to COVID-19."

"This new programme is additional to the UNDP-coordinated Global Environment Fund Ridge to Reef Project on Reforestation of Degraded Areas and the Ministry is actively engaging resourceowners to plant trees in the specifically identified watershed areas,"

"While our Pine Scheme communities are committed to re-planting trees that have been felled, it is encouraging to note that stakeholders in the sector have also been restrategizing to ensure they sustain the jobs of most workers.'

He adds the Pine Group of Companies had to temporarily close the Tropik Mill, however, it has continued to engage workers by redeploying them to re-planting and restoring harvested land.

The Ministry of Forestry intends to ensure that the forests and ecosystems we leave behind contribute to achieving our people's dreams and aspirations.

Minister tells of agriculture sector's vitality

EVER before has Fiji seen such unprecedented level of activity at household level in growing their own food supported by the Ministry of Agriculture.

These were the words shared by the Minister for Agriculture, Waterways and Environment, Dr Mahendra Reddy while updating Parliament during the May sitting last week as to how the agriculture sector has responded in the wake of COVID-19 and the effects of Tropical Cyclone Harold.

"It is through a clear and united national response that the agriculture sector has also been working tirelessly and vamping up our efforts to ensure food security and develop our vital agriculture sector to support the Fijian economy."

"For agriculture, it has provided us the opportunity to re-settle and re-energise agriculture focusing on the basics."

"Under the Home Gardening Programme which is aimed at all households, urban and peri-urban areas around Fiji, as at the end of last week (Friday) within less than two months since the launch of this package, we have distributed 36,495 seed packages to households across the four Divisions of Fiji, implemented across four waves in a relative short window."

Minister Reddy added they are now seeing Fijians proudly showing off the fruits of their labour through the assistance provided by the Ministry of Agriculture.

"Under the Farm Response Package, the Ministry is providing seeds and planting materials to farmers around Fiji at no cost to boost production of crops."

"There are two elements to this initiative. Firstly, it is demand-driven. Farmers select the seeds they require from a range of food, staple and nutritious crops such as taro, seeds and planting materials, taro, cassava, kumala, duruka, rice, vegetables, maize, bitter gourd, pigeon peas and cowpeas to name a few."

Minister Reddy said that all these are open-pollinated seeds, hence farmers can produce their own planting materials after the first assistance is given to them.

Ministry helps to rebuild cyclone-damaged homes

THE Ministry of Forestry has deployed portable sawmills to the islands to harvest the fallen trees which are being treated and re-purposed to re-build houses damaged during Tropical Cyclone Harold.

Line Minister Osea Naigamu highlighted this in Parliament during the May sitting last week where he stated that the initiative was being done in collaboration with the Fiji Pine Trust, the Ministry of Rural and Maritime Development and the Ministry of Housing and Community Development.

"In Kadavu alone, a total of 300 homes were completely destroyed and a further 586 homes were partially destroyed," Minister Naigamu said

"We have also extended assistance to Matuku, Vatulele and Ono-i-Lau through the provision of portable sawmills, training and capacity-building to empower communities to salvage blown-over pine for their housing needs. Our intention is not to leave anyone behind."

In addition to rebuilding homes, the Government, through the Ministry of Forestry, is continuing discussions with the resource owners to purchase the fallen trees and deliberating paying them stumpage, providing timber to build their homes and trading any surplus timber or to share the proceeds from timber sales.

"We are grateful to the retailers who have in-

dicated their willingness to purchase the surplus timber from the islands," Minister Naigamu said. "What this means is that there should be enough

timber available for our domestic needs and we could even consider exporting," he added.

Minister Naiqamu highlights that the Ministry has been consulting with stakeholders to understand their challenges and help address all issues

"Our consultations have, for instance, afforded the Ministry an opportunity to enhance its facilitation processes without compromising standards that will ensure the sustainable management of our forest resources," he said.

"At the same time, the Ministry is continuing Fiji's tree-planting initiative and have planted over 1.9 million trees and mangrove until date since its launch 15 months ago, with trees having been mapped and we now have a live dashboard," Minister Naigamu added.

He further adds the Ministry is continuing to plant trees within the COVID-19 social distancing measures with an aim to progress in earnest in the new fiscal year.

Fiji 'not alone' in adapting to post-pandemic world

INISTER for Commerce, Trade, Tourism and Transport, Faiyaz Koya has emphasised that Fiji will not be alone in having to adapt to a post COVID-19 (corona virus pandemic) world.

In delivering his maiden speech in Parliament during the May sitting last week, Minister Koya added, "But our challenge is greater than most, because of our smallness, our vulnerability to the climate change and geographical isolation."

"Being away for about 16 months from Parliament has given me a unique perspective and I have had the opportunity to reconnect with Fijians especially those at the grassroots and business community," Minister Koya said.

"I have made an effort to gauge the pulse of the nation and what Fijians needed for a better Fiji "

While speaking on the COVID-19 pandemic Minister Koya said, "this will not go away easily or in a short span of time. It will require tenacity, it will require hard work and it will require new ideas and there will be no return to what we may have known as business as usual".

"We therefore need to develop strategic and

in-depth approaches to human development, to regional integration, digitisation, industrialisation, economic diversification and international solidarity," he said.

"The Fijian Government has implemented a number of measures and economic stimulus packages to support Fijians."

Minister Koya added this was done by lifting certain financial burdens from the shoulders of those who are most vulnerable.

"We are also re-doubling our efforts and working tirelessly to engage with stakeholders through the help of technology," he said.

"At present industries such as medical services, biotech, agriculture, food production and delivery and information technology are growing."

Minister Koya said businesses in these sectors are seeing stronger demand and hiring more people

Govt focuses on efficient shipping services

HE FIJIAN Government will now ensure that shipping services provided to maritime islands are efficient and the vessels are providing safe services to Fijians living in the maritime zones.

This was the reassurance given by the Minister for Commerce, Trade, Tourism and Transport Faiyaz Koya in Parliament during the May sitting last week where he further emphasised the need to maximise the use of these particular vessels which at present are only really operating at about 30 per cent capacity. "The Ministry is working on implementing an approved 15-year contract duration for Government shipping franchise schemes. What this will do, its 20 years for the coastal trading licence of vessels. This will provide collateral for re-finance and re-fleeting of custom-built vessels by the private sector through the GSS vessel replacement scheme."

"This will sufficiently incentivise further investment into the industry and especially with the uneconomical routes and in addition it will encourage re-fleeting of people's fleets already and using newer vessels, et cetera."

Minister Koya added that an-

other important component that forms an integral part of this whole equation was the need to be compliant in terms of the climate so the vessels are environmentally friendly.

Meanwhile, Minister Koya reflected on the Government's current five-year and 20-year National Development Plan on Government's commitment to the shipping industry in the next five years

"Most paramount is the safety at sea which is an absolute key priority and one of the other considerations is actually environmental concerns. So, these are two places initially where the investments are but there are eight others."

"We rely on private sector investment and with private sector investment, we are looking to continuous investment through vessels that have been used by the private sector companies who provide inter-island services like Goundar Shipping, Interlink, Patterson Shipping and South Sea Shipping."

Apart from investment venture, Minister Koya further highlighted the need for infrastructure upgrade which also is a collaborative effort through FRA and the success of Fiji's development is dependent on.

Housing aid part of COVID-19 relief package

TOTAL of 277 applications were received by Housing Authority and 205 applications have been approved while 14 applications were declined and another 58 applications are still being reviewed.

This was highlighted by the Minister for Local Government, Housing and Community Development Premila Kumar while responding to queries on the COVID-19 Relief Provided by Housing Agencies in Parliament during the May sitting last

Minister Kumar said the debt relief assistance package offered by the Housing Authority of Fiji is for its customers who are facing financial difficulties in servicing their loans as a result of the COVID-19 pandemic.

This includes loss of income arising out of redundancies, reduced working hours, leave without pay and closure of small and medium businesses by those who are self-employed.

"Under the Relief Scheme, affected customers can apply for various options as prescribed by the Consumer Credit Act, Section 66, such as repayment holiday, extension of loan term for a period of up to six months interest only repayment, extending the term of the loan and reducing the repayment amount. All fees have been waived on the restructure of loan accounts under this Relief Scheme."

"The Public Rental Board (PRB), is also providing assistance to its tenants who are affected by COVID-19. PRB is offering rent deferment for three months. At the end of the rent deferment period or when the tenants are in a position to pay rent, they will enter into an agreement on the repayment of the deferred rent. This will be based on the household income and the level of disposable income

Minister Kumar also briefed Parliament on other initiatives that the ministry is undertaking to assist particularly those Fijians who work in informal settlements and live in HART.

"Rent charges for HART tenants are dependent on their weekly income and this can vary from subsidised rates ranging from \$1 to \$10 per week. Rent payment for all HART residents have been put on hold from 20th March of this year and will continue to be so amid the COVID-19 pandemic."

Islanders praised for post-cyclone resilience

PEOPLE of Vatulele have been commended for their resilience following the destruction and damages the four villages suffered during Tropical Cyclone Harold.

Prime Minister Voreqe Bainimarama, while visiting the island recently, reassured the villagers that Government will prioritise rehabilitation works for those islands that were affected by TC Harold.

"I had been visiting Lau and Kadavu groups with aim of ensuring that rehabilitation works are on track for those that have been affected. Government officials has also undertaken the various assessment work."

"I would like to acknowledge the efforts of those Fijians that have assisted through donations of food, water and shelter. Government will continue with its rehabilitation works and we are grateful for all the relief efforts that have come through."

PM Bainimarama provided an update of the relief work that has been carried out by the Government particularly in the agricultural sector.

He urged the villagers to utilise the seedlings that have been distributed by the Ministry of

Agriculture that will boost their source of food.

PM Bainimarama also highlighted the effect of COVID-19 to the Fijian economy particularly the global economy, Fiji in particular is on its way to having a 100 percent of being COV-ID-19 free.

However, he emphasised that this will depend on "how we as Fijians ensure adherence to all health warnings".

"I would like to urge parents and guardians to ensure that our children are monitored in light of the closure of schools."

"Only if Fiji is free from COVID-19 then we

can open all schools because our concern is that when our children begin to move around there is high-risk of spreading the disease."

"We still have three cases and according to the Minister for Health and Medical Services; they are recovering well. We still have a few in our quarantine facilities in Nadi that have to undergo the normal isolation period of 28-days. These are Fijians that are coming from India, Australia, New Zealand and some Asian countries."

PM Bainimarama briefed the villages of the continuous restrictions that are still in place to ensure that all Fijians are safe from COVID-19.

Fund promotes iTaukei culture, traditions, values

HE iTaukei Trust Fund Board (ITTFB) plays a pivotal role in ensuring the advancement of the iTaukei and Rotuman communities by promoting initiatives that will better their standard of living and enhance appropriate cultural traditions and values.

This was highlighted by Prime Minister and Minister for iTaukei Affairs Voreqe Bainimarama in Parliament during the May sitting last week while responding to queries on the review of the report on Trust Fund Board.

PM Bainimarama said in the TTFB Annual Report, 2017 had been a good year for the board in terms of fulfilment of its legislated objectives, particularly the various projects on language, culture and heritage developed in that year.

"Some of these programmes, such as the research on some of traditional funeral practices, focussing on the impact of these practices on the cultural, economic and religious wellbeing of indigenous Fijians.

Other practices have been translated into "Vosa Vaka Viti" and submitted to the iTaukei Affairs Board for dissemination and awareness."

"The curriculum on traditional leadership and governance titled, "Sauvaki ni Vanua", has been approved and registered by the Fiji Higher Education Commission as a Certificate III level course," the Head of Government informed Parliament.

"The 14-week course is written and taught in the iTaukei language. The offering of the course at the Centre for Appropriate Technology and Development (CATD) at Nadave started in November."

The program has attracted interest and had its first class of 23 students from Tailevu and Rewa provinces.

A cohort of students made up of schoolteachers and a number of the Ministry of iTaukei Affairs staff, undertaking the Diploma in Vernacular Studies continued with a total of six courses.

PM Bainimarama also adds that in collaboration with the iTaukei Institute of Language and Culture, two new comics of Fijian folktales - "Drevula Kata" and "O Dimailagi' are being illustrated as comic print productions, and Illustrator, Tuilevuka Ledua, was retained for the work.

PM joins global call for post-COVID-19 financing

RIME Minister Voreqe
Bainimarama joined the
UN Secretary General
António Guterres in calling for
global leadership to secure financing for development in the
era of COVID-19 and beyond.

The UNSG together with the Prime Ministers of Canada and Jamaica co-convened urgent virtual discussions to draw attention to the financing needed to respond to the social and economic impacts of COVID-19 on developing countries

The Secretary General told 50 World Leaders and the President of the World Bank, the Managing Director of the International Monetary Fund that the "World needed to act decisively and with great urgency to meet this human crisis".

The virtual discussions between world leaders and heads of multilateral institutions were focused on six pressing issues:

- The need to maintain financial stability to safeguard SDG development gains;
- The need to address debt vulnerabilities for developing countries;
- The need to create a space in which private sector creditors can proactively engage;
- Prerequisites for enhancing external finance for inclusive growth;
- Measures to foster domestic resource mobilization;

- Ensuring a sustainable and inclusive recovery.

Prime Minister Bainimarama drew the attention of the world leaders to the unique challenges that small states faced; the standstill in whole sectors of the economy such as tourism; the collapse of remittances and the deepening uncertainties in supply chains hit the smaller island states much harder.

Prime Minister Bainimarama told the UN meeting that the COV-ID-19 crisis "is not of our own making, and again, our economies are bearing the brunt of its consequences. Financial constraints and debt vulnerabilities risk widening the gap between the developed and developing worlds, between North and South. This time, the enemy we face is not climate change, but contagion. And neither one rests for the other".

"Fiji quickly rolled out strict di-

rectives to eliminate the coronavirus within our borders, and we've now gone over one month without a new case. But this pandemic's economic consequences have proved far beyond our capacity to constrain. With up to 40 per cent of our GDP dependent on tourism, our road to economic recovery winds long and runs steep".

"Just as a global health recovery cannot be confined to those who can most afford a possible new vaccine, a global economic recovery cannot be limited to those large economies who can unilaterally inject trillions into social and economic stimulus because of a superior position in the global financial system. Our global COVID-19 recovery must be bold, it must be coordinated, and inclusive".

"Developed nations have injected \$8 trillion dollars into their own economies, with more yet to come. If even the equivalent of one half of one per cent of this was dedicated to all the world's Small Island Developing States, it would provide us with the vital support we need. But to get there, we will need far greater creativity on the part of the IMF, World Bank, regional development banks, and most importantly, international solidarity among the world's large economies".

Prime Minister Bainimarama called for international solidarity that gives SIDS the "fiscal space to maintain and expand social protections, while maintaining economic stability and sustained economic growth. We need international solidarity that provides us with grant and concessionary financing on a scale that allows us to repurpose existing economic sectors and build new ones that are fit for a post-COVID era".

Biodiversity, climate change 'two sides of same coin'

MPLEMENTATION of nature based solutions such as the use of Vetiver grass for riverbank erosion and mangroves for coastal protection from storm surge, help us mitigate disasters.

This was highlighted by Minister for Agriculture, Waterways and Environment Dr Mahendra Reddy while delivering his Ministerial Statement in Parliament during the May sitting last week.

"We have the most amazing coral systems in the world. Distributed over 10,020 square kilometres of Fiji's marine inshore areas, it hosts a rich and diverse marine ecosystem. These reefs contribute immensely to our livelihood, food source, cultural values, and our nation's economy through tourism"

The Ministry launched the Policy on the Conservation and Management of Fiji's Coral Reefs on Vorovoro Island aimed at promoting the conservation and protection of Fiji's coral reefs and associated ecosystem.

Additionally to protect the coral reefs, the Ministry recently signed a letter of commitment that details the terms of engagement between the Ministry of Environment and Vulcan Inc. to collaborate on the use of the Allen Coral Atlas in Fiji for coral reef monitoring and management.

The Ministry through other national projects including Global Environment Fund Ridge to Reef, is getting various other government agencies including agriculture, forestry, fisheries, waterways, and infrastructure, and other sectors that use the land and that often are the primary drivers of biodiversity loss, implement projects to reverse biodiversity loss

Such projects include, reforestation programme, strengthening locally managed marine protected areas, promoting natured based solutions and Vetiver for riverbank stabilization.

"Biodiversity supports our current efforts to reduce the negative effects of climate change, through carbon sequestration. Moreover, conserving in-tact ecosystems, such as mangroves, helps reduce the devastating impacts of climate change such as coastal inundation and storm surges".

Framework protects endemic, threatened species

■IJI has committed to a number of conservation global frameworks to guide its conservation work on endemic and threatened species.

International Day for Biological Diversity was marked with a week-long program under the theme of "Our Solutions are in Nature" launched with the aim of creating more awareness in communities on the importance of protecting our natural environment.

This was highlighted by Minister for Agriculture, Waterways and Environment Dr Mahendra Reddy, while delivering his Ministerial Statement in Parliament during the May sitting last week.

Fiji's forests comprise 85.3 per cent of natural forests and continue to support the vast majority of the country's endemic fauna and

"Our forests have been identified as one of the most highly threatened ecosystems in the Pacific mainly due to conversions to landuse and development," Minister Reddy said.

"Biodiversity supports our current efforts to reduce the negative effects of climate change, through carbon sequestration."

Fiji is home to some 250 endemic species with more than 56 per cent having reported as threatened and 32 as critically endangered.

Common threats attributed include habitat loss, increase in invasive species, and the changing climate, affecting species population, distribution, resilience abil-

Furthermore, the Ministry in collaboration with the Biosecurity Authority of Fiji will develop a National Invasive Species Strategic Plan (NISSP) and develop Biosecurity protocols in support of native biodiversity within Fiji.



FSC aims to produce 200K tonnes of sugar

HE Fiji Sugar Corporation (FSC), is looking to produce between 195,000 to 200,000 tonnes of sugar during the 2020 cane crushing season.

FSC chief executive officer Graham Clark, while providing an update on the sugar industry during the launch of the rice planting initiative for canefarmers highlighted that out of this, FSC will export 170,000 tonnes to its major markets in five bulk shipments between July and December along with 80,000 tonnes of molasses in bulk exports from August to December. Mr Clark stated that the remaining 30,000 tonnes would be for the regional markets as well as for local consumption.

The three mills are expected to begin crushing from this month with the Labasa mill beginning on June 10, Rarawai on June 23 and Lautoka on June 24.

Mr Clark said the total sugar cane production has now been placed at around 1.85 million tonnes with total sugar export earnings expected to be approximately \$150 million which is 10 per cent short of the estimated two million tonnes forecasted at the beginning of the year.

"The drop in the crop estimate was due to Tropical Cyclone Harold. This ravaged cane farms in Sigatoka, Rakiraki and the North, most of which were inundated with floodwaters."

While acknowledging the Ministry of Agriculture for its swift action in providing rice seeds to the 12,000 sugarcane farmers, Mr Clark highlighted that they have a role to play in ensuring that the rice planting

initiative is a success.

Meanwhile, the fourth cane payment was given out to farmers on May 15 at \$17.78 per tonne of cane with a deduction of 67 cents.

Mr Clark explained the process of how the cane payments are made.

"All the cane payments that are made in Fiji are made in terms of the Sugar Industry Master Award. It's a document that's been around for a long time. It has legal standings amongst FSC and growers and we follow this to the letter.

"The fourth cane payment is governed by Clause 19.24 which requires that sugar proceeds up to the end of April are distributed to growers as soon as possible. Sometimes these payments are made around the end of May and this particular year with the trouble that everyone has been experiencing with the COVID-19 pandemic we were very pleased to be able to make the payment of the 15th of May. No more than two weeks from the month end."

Mr Clark highlighted that farmers would have received before their own personal deductions of \$13.06.

"So the deductions in question are two. Again, the Master Award provides for situations where there are certain costs that are either grower costs or miller costs that are Arbitrated by the Sugar Industry Tribunal, certified and a certificate is issued and only once the certificate is issued can anything happen in terms of the cane payment process

"This deduction of 67 cents was comprised of two deductions. The first one was the 2019 contribution of the farmers to the Sugar Research Institute of Fiji and that is governed in terms of the SRIF Act which is in turn incorporated into the Master Award

and that was via an amendment made to the Master Award back in 2009."

"So, we are guided by Section 21.1.4 of the Master Award which requires that on the production of a certificate from the Tribunal, the grower's contribution to the Sugar Research of Fiji Institute need to be deducted. That is equivalent to 50 cents per tonne of cane."

"Secondly, there was a small deduction of 17 cents which is a sugar cost adjustment that relaxed to the reprocessing of sugar last season which is now being certified. So together 67 cents of the total certified deductions. I think the issue is the disclosure of the deduction on the grower's statements."

He also stated that for the first time FSC had decided to try and push for more transparency and better accountability for growers so that they can track their payments.

An average of 100 daily email queries and 250 weekly phone calls were recorded in regards to the worksheets loaded on to the

"This indicates a high level of parental engagement which we have experienced at the Ministry in the last two months and, of course, this is commendable," Minister Akbar said.

"Radio broadcasts for four hours per day, three hours daily on two different stations, totaling 23 hours per week, started from 6 April, 2020 and as of today, we have aired a total of 66 Vernacular Lessons - 33 Hindi and 33 Vosa Vaka-Viti; and 116 Literacy and Numeracy Lessons through these radio stations," she added.

Employers 'have to rethink operational strategies'

■ MPLOYERS and corporates have been ✓ urged to think of ways and means of continuing or re-configure their operations as COVID-19 continues with no concrete timeline of returning to normalcy given.

This was highlighted by Minister for Employment, Productivity and Industrial Relations, Youth and Sports Parveen Kumar while delivering his ministerial statement in Parliament last week.

Minister Kumar said there is a need to continue to re-think how to do business and to create lines of employment that work within the health realities and guidelines currently in place.

"We have in place useful examples from our neighbours in Australia and New Zealand to create new lines and products to meet the pandemic needs. It is important that we continue to innovate within the ambit of current health regulation and the realities of COVID-19 pandemic."

"As supply chains open, it is important that we continue to re-think and think forward towards new and expanded market opportunities regionally among our Pacific Island neighbours for manufacturing and value-added goods. We already have an established pathway in this area and we should now look to expand this."

While the current survey is to provide data to meet current needs for planning during this COVID-19 pandemic, Minister Kumar adds that Fiji is not limiting it to just that.

"The survey will also provide the basis moving forward towards better planning for other crises dictated periods as this crisis has shown us that we can be better prepared in a range of areas in the workplace. For a start, we have already had to rethink how OHS regulations will work in pandemic situation."

"We know that while we have better chance, happier times are ahead, we will always have to deal with bad times as well and this survey provides an opportunity to be prepared for all that

This nation-wide workplace survey will also assist in updating the employers' base figures which is currently at 24,169 and how COVID-19 has affected this base figure.

The exercise involves the door to door survey of workplace establishment for 30 days.

Fijians encouraged to be job creators

THE Business License Reforms aims at the streamlining business in Fiji and encourage Fijians to be job creators. This was highlighted by Minister for Minister for Local Government, Housing and Community Development Premila Kumar during the May sitting of Parliament last week while providing an update on the Business License Reforms that came into effect on January 1, 2020.

The act of streamlining business processes aims to increase an organization's efficiency by simplifying tasks, bypassing unnecessary steps and cutting waste, all by using the most modern process modelling techniques.

Minister Kumar said by aggressively pursuing more streamlined businesses in Fiji they are encouraging more Fijians to become entrepreneurs which in turn attracts foreign business to invest in Fiji.

"By doing so, we aimed not only to increase Fiji's standing in the World Bank's ease of doing business ranking, but bring real and meaningful change that would help encourage new entrepreneurs and formalise existing ones," she

"Amid the economic uncertainty of COVID-19, I think we can all agree, these steps to streamline Fijian business are more crucial than ever, particularly when we are encouraging Fijians to be job creators."

"Firstly, we prioritised standardisation. Previously, the processes in place around the country differed, with different requirements and

Minister Kumar said thanks to the newfound standardisation, any Fijian who wishes to obtain a business license can now expect a decision within 48 hours of lodging their application.

"Now, under the new system, a

business licence is issued to lowrisk businesses that can start business and then have six months to ensure full legal compliance."

"This means that individual regulatory authorities will be directly accountable for their service turnaround time, adding efficiency and accountability across both, Government and the private sector."

For Titilia Bolakoro, 60, of Naocosaqa Settlement, the assistance could not have come at a better time as they have had cases of leptospirosis within members of their settlement.

China gives supplies to battle pandemic

These sentiments were shared by the People's Republic of China's Ambassador to Fiji, Qian Bo while handing over medical supplies to the Ministry of Health and Medical Services.

"I want to assure our friends in Fiji that China will continue to work in Fiji in combatting the Pandemic. What is more important is that we are focusing to further deepen the cooperation in areas of medical services," Ambassador Bo said.

"I am very happy that these goods have finally arrived because we have been waiting a very long time for those supplies to come," he said.

"We had two cases of leptospirosis in 2018 and this is the first assistance that we have received of this sort. We are elated and grateful that our community was among one of the many chosen to have these pit latrines installed for our restrooms. These plastic latrines are easy to clean and we are adamant that this will help us in the fight against water-borne diseases.

"For that we extended our gratitude to the Government and the organisations involved in bringing this assistance to our homes."

Fifteen pit latrine restrooms have already been commissioned, with 1000 more on the way to be produced by ROTA MOLD, and installed by Field Ready Organisation, in partnership with UNICEF.

One of the aim of this project is to ensure that Fijian children and families have access to proper toilets and hygiene facilities.

SMEs benefit from Govt initiatives

S your business earning an income less than FJ\$500,000 per annum?

If so, then it is a Small and Micro Enterprise (SME) for tax purposes and can enjoy a number of benefits that many SMEs have been enjoying through the incentives provided by the Fijian Government.

The Fiji Revenue and Customs Service (FRCS) has 28,984 registered SMEs in its database and in the last three years (2016 to 2018), these businesses have contributed \$378,763,052 in taxes towards the Fijian economy.

Transport and storage sector is the largest SME sector in Fiji with 2,740 registered businesses, followed by Agricultural sector with 2,213 businesses and Wholesale and Retail sector with 2,143 registered businesses respectively.

Incentives for SMEs

From 2016 to 2018, a total of 13,283 SME operators benefitted from the various incentives and duty concessions provided by the Fijian Government worth \$98.6 million. Out of the 13,283 SME operators that benefitted from these incentives, 13,226 are sole traders and 57 are companies with turnover of less than \$500,000 per annum.

Some of the incentives currently provided to the SME sector are Stamp Duty concession under the Stamp Act 1920, tax concession under the Income Tax Act 2015, and relaxation of taxable period under the VAT Act 1991. It is important that SME business owners know about these incentives so that they can utilise the opportunities of growth provided to them by the Fijian Government.

Stamp Duty exemption for SMEs


The Fijian Government announced the waiver of stamp duty on all instruments or written documents for SMEs effective from January 1, 2016.


Under the Stamp Duties Act, this waiver is available to any business that has an annual gross turnover or sale not exceeding \$500,000, provided it is a registered business with a valid business license, are tax and customs compliant and will be required to provide a Statutory Declaration confirming a gross turnover not exceeding \$500,000.

These businesses must provide copies of financial statements where applicable. The policy intention for this incentive is to assist the SMEs. Post assessment audits will be conducted to verify declarations. Penalties will be imposed where taxpayers make false declarations or scheme to evade this tax.

VAT Registration for SMEs

SMEs with turnover of \$300,000 or less per annum and are registered for VAT, also qualify to file





VAT returns annually instead of filing it monthly under the VAT Act 1991.

The intention of this policy is to give flexibility to SMEs to save cost and time associated with filing returns with accountants or Tax Agents as some may not be able to pay accountants and tax agents every month to make and file returns on their behalf

Announced in the 2019-2020 National Budget, all entities with an annual turnover of less than \$500,000 will be granted a free VAT Monitoring System (VMS) application software and a free smart card reader from FRCS. This has been effective from August 1, 2019 and to date there have been 729 successful SME assistance applicants for this.

Tax exemption to SMEs in the Agricultural Sector

All SMEs with an annual turnover is \$500,000 or less per annum and are involved in the agricultural sector qualify for Income Tax exemption under the Income Tax Act 2006 provided that their business income is only derived from the Agricultural activities.

However, the business will have to file the yearly tax returns stating the income derived and the subsequent profits generated. All those SMEs that are purely agricultural based and deal with raw and unprocessed materials (produce supplier) like dalo and kava also have the option of not registering for VAT regardless of their annual turnover.

In cases where businesses choose to voluntarily register for VAT, then they will have to charge and pay VAT to FRCS. However, if the SME is not registered for VAT then they cannot charge VAT on their supplies.

Dedicated SME Support Centre

FRCS has a one stop shop dedicated to the SMEs where all relevant Information are provided to ensure that this important business sector is enabled to better understand its tax obligations including registration, filing and payment obligations as well as to assist SME to meet Its reporting requirements.

Some of the advisory services available through the SME Support Centre located at the FRCS Head Office in Nasese includes:


and put the income they earn from competing aside. And I know how important sport is for ordinary Fijians — particularly when our national spirit needs lifting."

एक संस्था बिज़नस असिस्टन्स फीजी, जाँच करने के बाद तय करेगी कि किन-किन व्यापारियों को सहायता मिलनी चाहिए। इस संस्था में फीजी इंस्टीटूट ओफ अकाउन्टन्ट्स, फीजी चेम्बा ओफ कोमेस एन्ड इंडस्ट्री, फीजी कोमेस एन्ड एमप्लोयस फेडेरईशन, विमन इन बिज़नस तथा कोमेस मंत्रालय के नीचे माएको स्मोल एन्ड मिडियम एन्टाप्राईस के सदस्य होंगे। बिज़नस असिस्टन्स फीजी उन व्यापारियों की भी मदद करेगी जिन्होंने हाल ही व्यापार शुरू किया है ताकि वे भी कर्ज़ लेने वाली हर जरूरतें परी कर सकें।

अटेनी जेनरल ने कहा कि उन्हें पता है कि लोगों की नौकरियाँ चली गई हैं लेकिन उनमें अच्छे हुनर भी हैं जिसका वे उपयोग कर सकते हैं।

कुछ छोटे व्यापारियों को सरकार एक प्रतिशत ब्याज पर चौदह हज़ार डोलर तक कर्ज़ देगी। इसका

रिपैमन्ट, बेन्क से लिए गए कर्ज़ की तरह नहीं होगा। व्यापारियों को बता दिया जाएगा कि उन्हें एक साल में कितने पैसे वापस भरने हैं और यह व्यापारियों पर है कि वे बारह महीने के अन्दर इतना पैसा कैसे सकाते हैं।

मध्ययम व्यापारियों को इक्कीस हज़ार (21,000) डोलर कर्ज़ 1.5 प्रतिशत ब्याज पर मिल सकता है

तथा उन्हें यह कर्ज़ पाँच सालों में चुकाना पड़ेगा। पहला साल उनको ग्रेस पिरियड यानि छूट की अवधी मिलेगी। यह सहायता सात जून से प्रदान की जाएगी। कृषि, मछली और फोरेस्ट्री क्षेत्र वाले व्यापारियों के लिए अच्छी खबर है जो पचहत्तर (75,000) हज़ार डोलर तक कर्ज़ ले सकते हैं। इसका पचहत्तर (75)

प्रतिशत, लौटाने की गरन्टी सरकार देगी।

पशु पालन में शामिल किसानों की मदद की जाएगी

कृषि मंत्रालय, जेफ स्टा फीजी रिज टु रीफ योजना (GEF STAR Fiji Ridgeto-Reef (R2R) Project) के तहत पशु पालन में शामिल पाँच सौ अट्ठाईस (528) किसानों को तार लगाने के सामान प्रदान करेगा।

लेंगालेंगा रिसेच स्टईशन पर इसकी घोषणा करते हुए कृषि मंत्री डाक्टर महेन्द्र रेड्डी ने बताया कि ज्यादातर किसानों की ज़मीनों में तार नहीं लगे हैं और इस कारण से उनके जानवर चरने के लिए दूर जंगल-झाड़ियों और नदी-नालों के पास चले जाते हैं।

मंत्री रेड्डी ने बताया कि यह खुले जानवर काफी समस्याएं खड़ी कर देते हैं और दूसरों की ज़मीनों में जाकर फसलें बर्बाद करते हैं।

तार लगाने का काम बा, लम्बासा, रेवा/वाईंदीना, तुनोलोआ, तूवा और वुनिवया
में किया जाएगा। इस योजना
के तहत पिश्चमी विभाग
के दो सौ छब्बीस (226),
उत्तरी विभाग के दो सौ छब्बीस और केन्द्रिए विभाग के
छिहत्तर (76) किसानों की
मदद की जाएगी। हर किसान
को दस कोईल फेंसिग वाया,
दस कोईल कठईया तार,
बाईस पाईन पौस्ट, चार
किलोग्राम निला और बाईंडिंग
वाया दिया जाएगा।

नवाईदोम्बा नांदी के विवेन चन्द्रा सिंग्ह को इन सामानों से मदद की गई है और उन्हों ने इसके लिए सरकार को धन्यवाद दिया है।

"हम इस सहायता से बहुत खुश हैं। हमारे जानवरों की बड़न्ती के लिए यह बहुत ज़रूरी है और साथ साथ वातावरण को भी सुरक्षा प्रदान किया जाएगा।"

सरकार फीजी एयावईज़ के लिए चार सौ पचपन (455) मिलियन डोलर कर्ज़ की गरन्टी देगी।

इस संबंध में संसद में अर्थ-व्यवस्था मंत्री अईयाज़ सईयद खईयूम का एक प्रस्ताव पास हुआ।

स्थानीय तौर पर 191.1 मिलियन डोलर कर्ज़ लिया जाएगा जबकि विदेश से एक सौ सत्राह (117) मिलियन अमरिकी डोलर कर्ज़ लेने की योजना है।

इस साल तीस मई से अगले तीन सालों तक यह असर में रहेगा।

सईयद खईयूम ने कहा कि फीजी नेशनल प्रोविडन्ड फन्ड तिरपन दशमलव छ: (53.6) मिलियन डोलर कर्ज देगा, रिज़ेव बेन्क ओफ फीजी, एक्सपोट फायनन्स फसिलिटी लौन के द्वारा फीजी डिवेलोपमन्ट बेन्क को पचहत्तर (75) मिलियन डोलर देगा जो फिर फीजी एयावईज़ को कर्ज़ के रूप में दिया जाएगा क्योंकि रिज़ेव बेन्क सीधे कर्ज् नहीं दे सकता है। यह कर्ज़ तीन प्रतिशत ब्याज पर दिया जाएगा। अई एन ज़ेड बेन्क बावन (52) मिलियन डोलर देगा जबिक ब्रेड बेन्क दस दशमलव पाँच (10.5) मिलियन डोलर देगा।

अईशियन डिवेलोपमन्ट बेन्क भी पचास मिलियन अमरिकी डोलर देने को तैयार है लेकिन अई.डी.बी से कर्ज़ तबही लिया जाएगा जब यह स्थिति अगले साल तक इसी तरह बनी रहेगी।

मंत्री ने कहा कि फीजी एयावईज़ कुछ भी आमदनी नहीं कमा रहा है लेकिन इसके बावजूद वो हर महीने कर्ज़ के भुकतान के तौर पर अड़तीस (38)

मिलियन डोलर भरता है, विमा खरीदने के कर्ज़ के तौर पर बीस मिलियन डोलर तथा अन्य खर्च के रूप में छ: मिलियन डोलर भरता है।

मंत्री ने कहा कि फीजी एयावईज़ की उड़ानें सस्पेन्ड और रद्घ होने की वजह से उन्हें उपभोगताओं से लिए गए पैसे वापस करने पड़ रहे हैं क्योंकि सेवा बिलकुल भी प्रदान नहीं की जा रही है।

बिल में बदलाव लाया गया है कि अगर मज़दूरों के पास काम नहीं है, या कोविड-19 के कारण अगर वे सेवा नहीं प्रदान कर पा रहे हैं, तब मज़दूर मालिक उन्हें घर भेज सकते हैं।

विश्व स्वास्थ्य संस्था ने कोविड-19 को महामारी घोषित किया है और बिल में बदलाव करके महामारी को भगवान का कार्य बताया गया है।

अटेनी जेनरल अईयाज़ सईयद खईयूम ने बताया कि मज़दूर मालिकों को कानून की इस व्यवस्था से फायदा उठाकर कर्मचारियों को घर नहीं भेजना चाहिए।

''उदाहरण के तौर पर अगर व्यापार अच्छा चल रहा है, व्यापारी बिना कारण के मज़दूरों को घर नहीं भेज सकते। अगर वे बतायेंगे कि महामारी के कारण उन्हें लोगों को काम से निकालना पड़ रहा है, तब उन्हें यह साबित करना पड़ेगा," अटेनी जेनरल ने कहा।

कानून में बदलाव करके, कोविड-19 के दौरान, फेमिली केया और पटेनिटी लीव्य, पाँच दिनों से घटाकर दो दिन कर दिए गए हैं।

अटेनी जेनरल ने बताया कि इस महामारी के समाप्त होने पर सब कुछ समान्य हो जायेगा यानि फेमिली केया और पटेनिटी लीव्य, फिर पाँच दिन हो जायेंगे।

हैं जो एक सौ तईस (123) ज़मीन मालिकों के ट्रस्ट सदस्यों के बीच बाँटा गया। मंत्री उसामाते ने ज़ोर दिया कि मुश्किल की इस घड़ी में फीजिवासियों को एक दूसरे की देखभाल करनी चाहिए जबिक कुछ लोगों के पास काफी समय से नौकरी नहीं है।

"हम असाधारण समय में जी रहे हैं जबिक कोविड-19 विश्व अर्थ-व्यवस्था को लगातार नुकसान पहुँचा रहा है। समुद्री आँधी हेरल्ड की वजह

राहत वोटा सप्लाय के लिए डिसेलिनईशन प्लांट

मिनिस्ट्री ओफ् रूरल एन्ड मेरिटाएम डिवेलप्मेंट को एक मोबाएल डिसेलिनईशन प्लांट दान में मिला है जिसकी मदद से समुद्र के पानी साफ करके पीने योग्य बनाया जा सकता है।

"सी मेसी फीजी" ने एक साल के लिए मुफ्त में यह प्लांट दिया है जिसके साथ एक लाख डोलर मूल्य का जेनेरईटा है। यह प्लांट एक दिन में पचास हज़ार लिटज़ समुद्र का पानी साफ करके पीने योग्य बना सकता है।

प्लांट देते हुए सी मेसी फीजी के प्रतिनिधि नील टौना ने बताया कि वे इस बात से खुश हैं कि वे सरकार के साथ मिलकर लोगों को सेवा प्रदान कर पा रहे हैं। उन्होंने बताया कि समुद्र से घिरे द्वीपों में यह प्लांट काफी मददगार साबित होगा।

प्लांट स्वीकार करते हुए रूरल एन्ड मेरिटाएम डिवेलप्मेंट मंत्री इनिया सेरूईरातु ने दोहराया कि सरकार हर फीजियन को साफ और सुरक्षित पानी प्रदान करने की दिशा में काम करती रहेगी।

उन्होंने बताया कि पिछले तीन सालों में मंत्रालय ने

अपने एमेजेन्सी वोटा सप्लाय प्रोग्रेम के तहत समृद् से घिरे द्वीपों और सुखा पड़े इलाकों में पानी बाँटने में एक दसमलव दो मिलियन डोलर खर्च किया है। मंत्री के अनुसार इस प्लांट के आने से यासावा, लाउ और कन्दावू में पानी बाँटने के खर्च से बचा जा सकेगा। उन्होंने कहा कि इस तरह की योजनाओं से लोगों की ज़रूरतों की पूर्ती की जा सकेगी।

यह प्लांट ड्रावृनि और नन्गारा भेजा गया है जहाँ अगले बारह महिनों तक लोग इससे फायदा उठा सकेंगे।

किसानों को जानवरों की नई नसलें मिलेंगी

देश में मध्य और बड़े पैमाने पर पशुपालन करने वाले किसानों को सहयोग देने के लिए, कृषि मंत्रालय उन्हें पशुओं की नई नसलें प्रदान

कृषि मंत्री डाक्टर महेन्द्र रेड्डी ने हालमें घोषणा की कि पशुपालन का बढ़ावा देने के लिए यह बेहद ज़रूरी है। मंत्रालय का उदेश्य है, फीजी में बकरी, भेड़, गौमाँस और दूध से बने उत्पादनों का उत्पादन बढ़ाना।

''मंत्रालय गाय, बकरी तथा भेड़ों के लिए नई नसलें तैयार कर रहा है और यह नई नसलें कम बच्चें पैदा करने वाली नसलों की जगह लेंगी जो समय के साथ संख्या बढ़ाने के मूल लक्षणों को खो चुकी हैं। उन्होंने कहा कि संख्या बढ़ाने के लिए नई नसल के ब्रीडा बैल, बकरे और भेड़ बहुत सस्ते में किसानों को दिए जायेंगे जिन्हें किसान बेच

मंत्री रेड्डी ने कहा कि ऐसा करने से फीजी में माँस और दूध का उत्पादन बढ़ेगा और हमें विदेशों पर निर्भर नहीं होना

नहीं सकते न ही उनका सेवन

कर सकते हैं।

उनके अनुसार लोगों को भूलना नहीं चाहिए कि फीजी के पास दुनिया भर में माँस निर्यात करने की क्षमता है।

अगले एक महीने के अन्दर एक और योजना शुरू होगी जहाँ आने वाले तीन महीनों में मंत्रालय लगभग छ: सौ किसानों को तार यानि फेन्स लगाने का सामान देगा ताकि वे अपने पशुओं को उसमें रखें और उनकी संख्या बढ़ाने में उन्हें कुछ मदद मिले। फेन्स न होने की वजह से कुछ किसान जिनके पास भारी सं ख्या में पशु हैं, वे इन्हें बाँध नहीं सकते तथा उन्हें काबू में भी नहीं रख सकते।

इस साल के अंत में छ: सौ और किसानों की मदद की जाएगी तथा यह चलता रहेगा जबतक पशुपालन करने वाले सभी किसान जिनके पास ज़मीन है, की मदद नहीं हो जाती। इसके लिए मंत्रालय को छ: लाख (\$600,000) डोलर दान मिला है।

पिछले बारह महीनों में इस तरह से चार सौ किसानों की मदद की गई है।

इसके अलावा जो लोग मुगी पालन करना चाहते हैं को हर चार महीनों पर मुफ्त में मुगी के छ: से बारह बच्चे भी दिए जायेंगे ताकि लोग इनकी

संख्या बढ़ाकर अपने घर में आमदनी ला सकें।

अग्रीकल्चा माकेटिंग अथोरिटी में सुधार हुआ

अग्रीकल्चा माकेटिंग अथोरिटी में सुधार लाया गया है जहाँ नया बोर्ड और नए चीफ एक्ज़ेटिव ने अथोरिटी की कुर्सी सम्भाली है। कृषि मंत्री डाक्टर महेन्द्र रेड्डी ने बताया कि अथोरिटी देश भर में तेरह (13) नए कोलेक्शन सेन्टस बनाना चाहती है।

उन्होंने कहा कि किसानों के साथ कोन्ट्रेक्ट तैयार किया जायगा जहाँ अथोरिटी, किसानों के खेत से उनका उत्पादन खरीदेगी या किसान कोलेक्शन सेन्टर तक अपना सामान पहुँचा सकते हैं।

अथोरिटी किसानों से दुरूका, मिर्च, दाल, हल्दी तथा बीन जैसे उत्पादन खरीदेगी।

उत्पादन के लिए दाम पहले से तय किए जायेंगे। मंत्री ने कहा कि यह एक नई योजना है और नान्दी के एक सौ किसान कोन्ट्रेक्ट पर खेती करने के लिए अग्रीकल्या माकेटिंग अथोरिटी के साथ समझौते पर हस्ताक्षर कर चुके हैं। उनके अनुसार इन किसानों की यह चिन्ता दूर हो गई है कि उनका उत्पादन कौन खरीदेगा। समझौते में साफ लिखा है कि उनका उत्पादन अथोरिटी खरीदेगी।

मंत्री के अनुसार किसानों को तुरन्त उनका पैसा दे दिया जाएगा और उनका उत्पादन बेचने के लिए बाज़ार लेजाया जाएगा।

अथोरिटी के चीफ एक्ज़ेटिव एल्विन शर्मा ने बताया कि जो किसान अथोरिटी के साथ कोन्ट्रेक्ट पर हस्ताक्षर करेंगे, को खेत तैयार करने या मशीन खरीदने के लिए, उनकी फसल के हिसाब से पैसे पहले दिए जा सकते हैं। शर्मा ने बताया कि कोरोनावायरस की महामारी के दौरान जब लौतोका और सूवा में लोकडाउन हुआ तो अथोरिटी ने विभिन्न किसानों से पाँच लाख डोलर (\$500,000) लागत के सामान खरीदकर मार्केट तक पहुँचाई थी।

उधर, कृषि मंत्री ने ज़ोर दिया है कि अभी कृषि व्यवसाय में जितना अवसर प्रदान किया जा रहा है वो फीजी के इतिहास में कभी प्रदान नहीं किया गया

उन्होंने कहा कि वे चाहते हैं कि किसान कृषि व्यवसाय को एक व्यापार की तरह देखें, मेहनत करें तथा पुरे समय के लिए किसान बनें क्योंकि कृषि मंत्रालय उनकी सहायता के लिए खड़ा है। उनके अनुसार साथ मिलकर कृषि व्यवसाय को देश का सबसे महत्वपुर्ण व्यवसाय बनाया जा सकता है।

अईयाज़ सईयद खईयूम ने बताया कि दूसरे और से मिलाकर उन्हें इतने पैसे दिलवायेगी। दौर की सहायता के तहत जो लोग बेरोजगार हैं, वे एफ एन पी एफ से एक हजार एक सौ डोलर निकाल सकते हैं। मंत्री ने बताया कि अगर कोई सदस्य के जेनरल अकाउंट में इतने पैसें नहीं हैं, सरकार अपनी ओर से मिलाकर उन्हें इतने पैसे देगी। यह पैसे पाँच इनस्टोलमेंट्स में यानि हर दो सप्ताह में दो सौ बीस डोलर दिए जायेंगे। अटेनी जेनरल के अनुसार जिन बेरोज़गार लोगों ने सहायता के पहले दौर के दौरान सहायता के लिए अर्ज़ी नहीं लगाई थी, वे एक ही बार में एफ एन पी एफ से एक हजार एक सौ डोलर प्राप्त कर सकते हैं। उन्होंने बताया कि अगर उनके अकाउंट में इनते पैसे नहीं है, सरकार अपनी

अईयाज़ सईयद खईयूम ने जानकारी दी कि एफ एन पी एफ के जिन सदस्यों के अकाउंट में पैसे नहीं बचे हैं, या जिन सदस्यों के अकाउंट में पैंतीस (\$35) डोलर से कम हैं, उन्हें पहले

दो सप्ताह में दो सौ बीस डोलर दिए जायेंगे। "इन लोगों को हमारे पास या एफ एन पी एफ जाकर कोई फोम भरने की ज़रूरत नहीं पड़ेगी क्योंकि हम जानते हैं कि उनके अकाउंट में पैंतीस (\$35) डोलर से कम पैसे हैं और उनके बेंक अकाउंट में दो सौ बीस डोलर जमा कर दिए जायेंगे। लगभग बीस हज़ार लोग इस सहायता के हकदार हैं," अर्थ व्यवस्था मंत्री ने कहा।

सरकार इन बीस हज़ार लोगों (20,000) को चार दशमलव चार मिलियन डोलर (\$4.4 m)
