## COVID jab 'only way to fight virus'

MORE than 90 per cent of Fiji's target population have received their first jab while more than 35 per cent are now fully vaccinated against the COVID-19 virus. Despite the various challenges thrown in its way, such as the misinformation being spread on social media, the Ministry of Health and Medical Services vaccination teams have reached far and wide to ensure no Fijian is left behind. From mobile vaccination clinics to drive-through centres, the best protection against the pandemic has been made available to all those Fijians eligible for the jab. Prime Minister Vorege Bainimarama has called on the media to play its part in curbing misinformation. "I urge every one of you in the media to continue to play your part in fighting misinformation and vaccination hesitancy amongst our people by reporting the facts and seeking proper context, and -- as a direct result-- helping us save lives," he said.

Fiji hopes to open up its borders once more than 80 per cent of the target population is fully vaccinated.

# Mark major milestone, **President tells students**

O mark the eighth anniversary of our Fijian Constitution, the President Major-General (Ret'd) Jioji Konrote is calling on students to help Fiji mark this milestone.

"This Constitution Day, I am asking our students to speak to their nation about the importance of a very important constitutional right — the right to social security schemes; the net of social safety that upholds the dignity of those most vulnerable."

"I am calling on our students to tell us, or better yet, show us, how their lives, or the lives of someone they love, have been made better by a social protection programme," President Konrote said. He said the topics can vary from

the free water or subsidised electricity initiatives, free education, subsidised transportation to school, or the new initiative to provide sanitary pads for young women enrolled in school.

"You can speak on the poverty benefit scheme, social pension scheme, disability allowance, the child protection allowance, the food voucher programme for rural pregnant women, the subsidised bus fares for the elderly and those living with disabilities, or the unemployment benefits provided by the government or the food rations we are providing to people under home isolation orders.'

"Or you can talk about how all of these programmes work together to protect our people, including those most vulnerable, particularly when times are tough," President Konrote

said.

"It doesn't have to be personal testimonial; you may simply tell us why you believe these protections are so important to the nation. We want to hear your voices, whether that's through video or an essay."

"You can make a submission as an individual. You can make a submission as a family. What is important is that you express yourself creatively and that you stay engaged with your education even while you learn at home."

He also urged Fijians to come forward, as he has done, to be vaccinated.

"It is the right decision for your health, for the health of your families, and for Fiji," President Konrote said.

This follows the signing of a memorandum of agreement (MoU) for a funding arrangement towards the VitiKart Subsidy Scheme with the Reserve Bank of Fiji (RBF), and Vodafone Fiji Pte Limited recently where businesses can engage in e-commerce through the existing Viti Kart online platform without having to invest in costly infrastructure. The allocation of \$1 million provided by the RBF and \$150,000 by the Government annually towards this initiative had been announced in the 2021-2022 Na-

tional Budget.

"We want MSME businesses to flourish and we also want to be able to ensure that you participate in the digital space, and this is one very good way of sustaining and building back our economy and of course creating jobs at the same time," the A-G added. RBF governor Ariff Ali said, "MSMEs play an important role and are the largest employers in Fiji and this platform allows for an expansion of their business not just for Fiji but to the rest of the world".

"We are very keen to support this initiative and the Government's long term plan to ensure that we encourage more digital payments in Fiji," he said.

"One of the things we have seen products online. A customer anyunder the current environment is where in the world can purchase that a lot of people are buying things online so when MSMEs join the Viti Kart, they won't have to pay for infrastructure," he added. Vodafone Fiji chief executive officer Pradeep Lal said the company has continued to come up with various products and services such as M-PAiSA digital wallet which has been very useful. He said there are 25 live merchants who advertise their products with Viti Kart and about 50 merchants are in the process of being signed up. "To date, \$1.8 million of transactions has gone through Viti Kart a user friendly platform that pro-

vides easy access to log on to a particular product," he said.

"We are confident that this will allow more MSME and businesses to get on board to sell their through Viti Kart and the product would be delivered to their family and friends in Fiji." "This platform is one year old and it has been a success with over 70,000 people have downloaded the application on their phones while through the website there are about 230,000 users using this platform," he added. The scheme will provide grant to cater for the monthly subscription fees for eligible MSMEs registered on Viti Kart between the period of 1 August 2021 and 31 July 2023, for a period of two years.

cycle. The fund will be used for the many strategies that the ministry needs.


This was highlighted by the Minister for Health and Medical Services Dr Ifereimi Waqainabete while responding to the 2021-2022 National Budget during the Parliament sitting held recently.

"I want to bring to this House that on 12 July 2021 Public Health (Amendment) Act 2021 came into force which spells out our legal responsibilities to support the collective effort towards controlling and stopping the COVID-19 outbreak in Fiji.'

"It is imperative that we promote COVID safe measures so that we can bring this outbreak under control."

"On the amended legislation, I would like to thank the Ministry of Commerce, Trade, Tourism and Transport, municipal councils, and the Fijian Competition and Consumer Commission and the Police Officers who are enforcing the COVID safe regulations. Under this amendment of the Public Health Act, fixed penalty offences have been gazetted for around 23 offences which carry fixed fines ranging from \$20 to \$4,000."

Minister Waqainabete commended the various agencies and in particular the Fiji Police Force



"In the first week the Police team have conducted 556 bookings of these 245 bookings were related to face masks, 89 bookings, were in relation to Public Service Vehicles, 69 bookings were for gathering offences. I am just hoping that these bookings will reduce because it will show that we are continuing to embrace the COVID safety measures."

"The Digital Fiji team has assisted in setting up online payment systems to avoid queuing and unnecessary contact and other payment system like M-PAiSA or MyCash, internet banking transfer or direct deposit has also been activated."

"In relation to the vulnerable groups with people with elderly the disabled, the Ministry in the 2021-2022 will continue to support those living with chronic disease."

"These groups include those living with chronic diseases, those with compromised immune systems, older people over 60 years of age, children, women and in particular pregnant mothers, people living in geographically remote areas, and the unvaccinated."

Minister Waqainabete added the Ministry has developed targeted messaging for people with comorbidities and pre-existing conditions.

National and community-based vaccination drives have included drive through vaccination programs, targeted vaccination for pregnant mothers with the Moderna vaccine, and home vaccinations for the elderly and physically disabled.

Continued advocacy on public health measures including social distancing, restriction of movement, hand-washing, appropriate masking.

"Like any proper lessor they will continue to enforce the terms of leases. If any lessee violates the terms and conditions of their lease on iTaukei land, the TLTB will hold them accountable. # Mass vaccination, herd immunity 'the only way'

THE Minister for Local Government, Housing and Community Development, Premila Kumar considers the 2021-2022 National Budget as bold, practical and a responsive budget which supports the Fijian economy, businesses and households.

While speaking in Parliament recently, Minister Kumar highlighted that "the pinnacle of this budget is the national objective to fully vaccinate Fijians by 31 October to attain herd immunity

"The 2021-2022 National Budget is based on three objectives: protection from the virus through herd immunity; support for those hardest hit and future-proofing Fiji from future pandemics, effects of climate change and diversification of our economy beyond

#### tourism."

"The only way we can reopen our borders, ensure mobility and economic recovery is through mass vaccination of our people as vaccination will not only save lives but also save our livelihoods," she said.

A recent data released by the Ministry of Health and Medical Services states that Fijians have lost their lives mainly because they were not vaccinated nor had their first jab, while the World Health Organization global data also states that nearly all serious cases and death can be prevented if one is fully vaccinated.

Minister Kumar states that the Fijian Government took the "No Jab, No Job" step to protect Fijians from this highly infectious new Delta variant and that Fiji has joined 15 other countries that imposed some form of compulsory vaccination for certain groups of people.

"These countries include Vatican City, Australia, Greece, Italy, France, Indonesia, Saudi Arabia, to name a few and other countries are also contemplating this as well," she said.

Minister Kumar adds that the Fijian Government has been consistently releasing messages that vaccination is the only way to protect everyone and those who refuse to get vaccinated, will be the cause for extending the pandemic.

"We certainly do not want "pandemic of unvaccinated" when masking and social distancing restrictions are lifted for fully vaccinated Fijians," she added.

Minister Kumar further thanked the thousands of Fijians who took the jab to assist Fiji in returning to normalcy.

## Support stepped up for agriculture sector

**COUR** agriculture sector work is continuing – we will take agriculture to a different height, a different place."

This was highlighted by the Minister for Agriculture, Waterways and Environment Dr Mahendra Reddy in Parliament for the Ministry of Agriculture's fiscal year 2021-2022 allocation.

Minister Reddy stated that the agricul

Agricultural outputs increased by 97.2 per cent in 2020 as compared to 2013 and agricultural produce exports have surpassed the hundred million mark.

"We are also doing a lot of work in terms of promoting the core high value procurement that is pushing our export sector. We have turned around the rice industry, thanks to Fiji Rice Limited for supporting the initiative. Also thanks to the Government of China for providing us support with regards to the agriculture machinery." "We are setting up a model farm in Lautoka, thanks to the funding from the European Union through our NGO partner Dialogue Fiji. The model farm will have a hydroponic setup - we will have a nursery, a drip irrigation set up on the farm. As we speak, it is under construction and it should be ready in three weeks' time for running of short courses training of farmers," Minister Reddy stated.



## Focus set to protect, prioritise environment

THE Ministry of Waterways and Environment will continue to focus on protecting and prioritising the environment. This assurance was made in Parliament by the Minister for Waterways and Environment Dr Mahendra Reddy while contributing to the debate on the 2021-2022 Budget Appropriation Bill.

Minister Reddy said the ministry will ensure that resources are sustainably utilised, all developments are sustainable, ozone layer protected and waste was properly managed.

The Ministry of Environment received a budgetary allocation of \$4.7 million to ensure various works are undertaken by the ministry including the extension of the Naboro landfill that has been allocated \$1.5m.

Minister Reddy explained that \$132,000 has been allocated for preventing pollution as the Department of Environment was well aware that preventing pollution reduces financial and environmental costs overlays.

With an allocation of \$4 million, he said that the ministry supports the twin Job for Nature Programme that was announced by the Minister for Economy.

"I am pleased to announce that the Department of Environment under the able leadership of our Permanent Secretary, Mr. Wycliffe and Director Environment, Ms. Sandeep Singh, we were able to secure more than \$18 million over the last 24 months in external donor funding to support our biodiversity conservation and environmental protection work."

"The various donor and development partnership including the Global Environment Facility (GEF), European Union (EU) and the (Jeff) Bezos Earth Fund. Jeff Bezos, founder, and the Executive Chair of the online retail giant Amazon announced the establishment of the Bezos Earth Fund in February, 2020," Minister Reddy said.

He said this "philanthropic move committed US\$10 billion (FJ\$20.8b) with the express goal of helping preserve and protect the natural world and with an emphasis on social justice as climate change disproportionately affects the poor and marginalised communities." This global initiative is intended to fund scientists, activists, nongovernmental organisations and or any effort that ensures a real possibility to help in the conservation and protection of natural resources. "The Department has also secured another investment of \$600,000 from the World Wild Life Funds for Nature (WWF) to support our mangrove conservation project," Minister Reddy said.

ture sector's two main objectives are to provide food security for Fijians and to expand the sector for the nation's benefit.

"Of the period 2010-2019, the nonsugar cane agriculture Gross Domestic Product grew at a compound rate of 6.3 per cent. It increased from \$343.6 million in 2010 to \$630.2 million in 2019 - a massive 83.6 per cent increase."

"The return on investment, every dollar that we invest in agriculture, provides \$9 in the agriculture sector. In 2019-2020 period, the return on investment in agriculture, every dollar that you invest, the Government money that we invest in agriculture provides return of \$9, compared to 57 cents in the sugar sector. Minister Reddy also made it clear in Parliament that support towards agricultural growth and development will continue so that every Fijian engaged in the progress of the agriculture sector will reap the rewards of their hard work.

"The great news is that we have enough vaccines for our entire eligible population and if we fail to vaccinate 80 per cent of the target population by November 2021, we will be amongst those shut to the world," he said.

"The Fijian tourism industry has been one of our greatest supporters from offering accommodation for quarantine, to vehicles and personnel, to reaching out to communities as part of our vaccine drive and we are grateful and thankful to them for doing so."

"As we did with the Fijian COVID Safe Economic Recovery Framework, we have mapped out a three-tiered approach to safely reopen the tourism industry and with vaccine passports and the Tourist Insurance Scheme, we have now put ourselves on par with our markets," he added.

# Three-tiered pathway to reopen tourism industry

HE Fijian Government has mapped out a three-tiered approach to safely re-open the tourism industry.

Speaking in Parliament in his budget response, Minister for Commerce, Trade, Tourism and Transport Faiyaz Koya highlighted this and stated that with the vaccine passports and Tourist Insurance Scheme, Fiji has now put itself on par with our markets.

"The \$40 million Fiji Recovery Rebate Package and travel stipend will serve its purpose. With pent up demand and only a handful of destinations accepting tourists, competition will be stronger than ever.

"Our best hope for tourism resumption or any resumption really is vaccines. The longer we take to reach our vaccine target, the longer our borders remain closed, the longer businesses struggle, and the longer Fijians remain without jobs."

Minister Koya stated that in the 2021 assessment, for the first time, Fiji has been acknowledged for "positive" reforms in three indicators - Starting a Business; Obtaining Construction Permits; and Getting Credit.

He said that ranking is not the only measure for Fiji's progress in improving business procedures and processes.

Minister Koya added that the 2021-2022 National Budget was "designed to empower Fijians and businesses, so there is some normalcy and we are able to enhance and create some economic activities."

"Whether unemployment benefits, fees and fines, or providing comfort to focus on getting businesses off the ground, or not having to worry about loan repayments for at least two years - we are here. \$200m for unemployment support; over \$50m in other reliefs like free electricity, food distribution, over \$120m in social welfare; free education and support to tertiary students."

Minister Koya also reassured that there is support for businesses in the new budget which includes the \$200m worth of financing support for businesses.

"Guaranteeing loans between 80-90 per cent for Micro, Small and Medium Enterprises (MSMEs) and paying interest for two years will free up their minds to think bigger and better along with the \$1.2m for monthly and upfront costs to get MSMEs on to the Viti Kart platform."

"The Ministry, Reserve Bank of Fiji (RBF) and Vodafone, our very own company, will have as many MSMEs, especially, those licensed under the Fijian Made-Buy Fijian campaign."

### 20 transport initiatives to help all Fijians MEREANI GONEDUA

THE 2021-2022 National Budget provides more than 20 transport related initiatives across all sectors. Some of these include Social Welfare assistance on Bus Fare Support for the elderly, for the disabled and transport assistance for primary and secondary students Minister for Commerce, Trade, Tourism and Transport Faiyaz Koya, while speaking in Parliament recently, highlighted that transport is a critical sector for the economy whether land or sea as it is cross-cutting therefore an important link for development. # Biden pledges support for pandemic, climate crisis

T the invitation of the Pacific Islands Forum Chair, Prime Minister Vorege Bainimarama, Unit-Led States of America President Joseph Biden addressed the meeting of the Pacific Islands Forum.

During the PIF meeting held recetly, the US President pledged America's support to the Pacific in overcoming the COVID-19 pandemic and raising global ambition to tackle the climate crisis.

"Mr Prime Minister, thank you for the invitation and for Fiji's leadership of the Forum through a time of significant challenge to the region and to the world," said President Biden.

"Of course, there is no more immediate threat to all of us than COVID-19. This pandemic has taken a heavy toll and the lives lost can never ever be replaced. The economic impacts are going to require all of us to work together to drive an inclusive and sustained recovery."

"The Pacific Island nations know better than anyone that averting the worst effects of climate change is going to save lives," said President Biden.

"The United States is committed to dramatically reducing our emissions by 2030 and building resilience in vulnerable communities globally."

In response PM Bainimarama said, "Vinaka vakalevu, President Biden, for making history as the first US President to join us at the Forum, and for bringing America forcefully back to the right side of climate history."

"Fiji and the USA's net-zero commitments by 2050 must become the entire world's — zero excuses. Together — as a united Pacific — we look to securing a historic outcome in Glasgow at COP26 which brings the 1.5-degree Celsius target within reach."

Prime Minister Bainimarama also welcomed President Biden's pledge of half a billion doses of the Pfizer COV-ID-19 vaccine through the COVAX Facility.

"This global pandemic only ends one way: By vaccinating as many people as possible around the world as quickly

as can be done," he said. "Much of the Global South is well behind developing nations in terms of protecting their populations — and the United States has a vital role to play in ensuring all people have the opportunity to be protected against the virus through vaccines."

The Prime Minister also extended an invitation to President Biden to visit Fiji.

"We hope you can visit us in Fiji, where you'll see the struggle -- and the solutions — at the front line of the climate crisis."

The 51st Forum meetings will continue in the coming months with the Forum Chair leading virtual dialogues with civil society, the private sector, Forum dialogue partners and other regional organisations. A plenary will be held with associate members and Forum observers. A Special Leaders Retreat is planned on the margins of COP26, and an in-person Leaders Retreat is planned for Fiji in January 2022.

Founded in 1971, the Pacific Islands Forum is the region's premier political and economic policy organisation and it comprises of 18 members: Australia, Cook Islands, Federated States of Micronesia, Fiji, French Polynesia, Kiribati, Nauru, New Caledonia, New Zealand, Niue, Palau, Papua New Guinea, Republic of Marshall Islands, Samoa, Solomon Islands, Tonga, Tuvalu, and Vanuatu.

## Vatunitu shares her experiences as a frontliner

**G SOMETIMES** the hardest part of my job is having to be chased by those who are scared to get swabbed or to get vaccinated."

These were the words of an emotional staff nurse Elenoa Vatunitu who has been serving as a nurse for more than 16 years and is now part of the COV-ID-19 operation team in Nadi.

The 38-year-old, who hails from Nadroga, said that a normal day of work during this pandemic would involve travelling to various locations including villages to conduct swabs for suspected cases.

"I find that the most challenging aspect of my job is sometimes having to deal with people who are scared because of rumours that they have heard."

When this occurs, Ms Vatunitu stated that they would be required to tell the villagers about their work and how it benefits them.

"Once this is done, then people will begin to understand, and we will be able to do our jobs well. On the other hand, we have our awareness teams to provide the public with more information."

"I have been away from my family for more than three months and even though its hard at times I am grateful for the support system that I have back home.

"Every day my two kids call to tell me how much they miss me, but I always tell them that I am out here helping sick people and sometimes this message helps them better understand the type of work that I do."

"My family and God are my greatest motivations, especially in these challenging times, and serving others has always been my calling.

"I urge everyone to please listen to advisories and take heed of the COVID safe measures."

"I ask every Fijian out there to continue to pray for the frontliners and to accept us into your communities or villages when you see us coming."

"I also urge those of you who haven't already been vaccinated to do so, as it will not only protect you but those around you, especially those you love."

### Swami tells: It is about serving people: Mereani gonedua

**G** IT is about serving people and that's what our job is about."

These were the sentiments of 24-year-old civil servant Prashant Swami who serves as one of the frontliners in the Nadi district.

Mr Swami, who works with the Department of Immigration office based at the Nadi International Airport, highlighted that it was an honour to be working with health officials during this pandemic.

"I have been with the Nadi operation team since April along with other civil servants and I can tell you that the work is scary especially when you know you are traveling into a red zone. At first when I started I was scared but then working along health professionals and reassuring myself that I am serving my people is what keeps me going."

"I sometimes travel with our swabbing team including our contact tracing team where I am required to note down details of a person whom we examine and sometimes we face difficult situations such as people not accepting us into their homes however we try our best to understand what everyone is going through.

"Our work begins at 8am everyday including some weekends and we have no time to waste during our work as lives depend on what we do. I've seen many health workers I've worked with including my colleagues clock out after a days work at 3am however they continue to strive forward without any complaints.

T is our patriotic duty to help our country in times of need, and that is one of the main reasons we are vaccinated.

These were the sentiments expressed by Lautoka-based Taxi 5 Operators Association secretary Jai Suresh who has called on his fellow public service providers to get vaccinated.

In addition to stating that the association believes the vaccine will save many Fijian lives, Mr Suresh added that Fijians should not believe the false rumours about the vaccine.

"As part of our social respon-

sibility, we already have begun campaigning to our passengers by putting visible signs inside our taxis requesting them to get fully immunised and are the only service provider to take this on." Mr Suresh stressed that all Taxi 5 members were administered the AstraZeneca vaccine without any side-effects, and that Taxi 5, given the widespread transmission of COVID-19, is a suitable mode of transport.

"At the moment we are only transporting three passengers in compliance with the COVID - 19 protocols and have implemented other COVID-compliant measures for the convenience of our passengers." Being the youngest of five siblings, Mr Swami is the only one who lives in Viti Levu whereas his family resides in Vanua Levu.

"I miss them everyday and I tell myself that all this will come to an end and when it does then we will have a chance to meet.

"I only have one request to every Fijian out there and that is to follow advisories, vaccinate and keep every frontliner in your prayers."

## **Reforms for social protection programmes**

NE of the main priorities for the Ministry of Women, Children and Poverty Alleviation (MWCA) next year will be the reform of the social protection programme.

Ministry of Women, Children and Poverty Alleviation permanent secretary, Jennifer Poole, said the reforms of the social protection programme includes the revision and strengthening of the Management Information System (MIS) and the gradual automation of social welfare schemes to improve services to the public and provide greater accountability and stronger data management.

"The national coordinator for social welfare reform (a new position approved in 2021) shall lead this process and the position and resources for reform are well supported under this budget."

"The Ministry is committed to accountability and transparency. The Review of Social Protection

Program's budget item resources aspects of the Ministry's social protection strategy, particularly, internal verification and validation of client eligibility. It ensures the eligible target groups can access vital social welfare schemes in a timely manner."

Ms Poole also acknowledged the Ministry of Economy for launching new initiatives to support those who are newly unemployed due to the impacts of the pandemic coupled with other government assistance schemes that will be made available in the new fiscal year to assist some newly affected individuals.

"The Department will continue to conduct its reviews so they can ensure those who most need the assistance are prioritised and those who no longer need the assistance can be exited from the programme, making room for others that will be applying in the New Year."

Ms Poole said the Ministry is the Government agency responsible for the welfare of women, children, people living with disabilities, the elderly, the poor and the vulnerable.

"It also has the important responsibility to coordinate, consult and facilitate assistance to this clientele as well as empowering those who are disadvantaged, "leaving no one behind" The MWCPA has received \$145,517 million for its operations in the new financial year. We have been allocated adequate resources for the social protection programs and initiatives."

Ms Poole added that this allocation adequately resources the MWCPA to implement its core programmes while the reductions reflect an adjustment related to spending in the current financial year due to the number of beneficiaries brought about by internal verification controls like the recertification exercise which removed 7000 beneficiaries across the three major programs as well as changes and realignment of activities due to the COVID19 context

## Ministry, councils discuss policy, initiatives

THE Ministry of Local Government is in consultation with all municipal councils nationwide regarding policy reforms and initiatives for the new fiscal year 2021-2022.

One of the major changes for the councils is the change in the financial year, which will now be aligned with the Government's fiscal year beginning from 1 August 2021 to 31 July 2022.

This modification is by virtue of an amendment to the Local Government Act 1972. The change in financial year will align budget planning and financial reporting by the Councils with that of the Government, to ensure easier acquittal processes for projects and grants which is funded by the State.

"The ratepayers are reminded that the Municipal Councils are in the midst of issuing rates notice for the new financial year starting from 1 August 2021 to 31 July 2022. Most councils have taken the initiative of providing incentives to the ratepayers in the form of discounts to encourage ratepayers to pay off their rates early.

"As we are battling the Covid-19 Pandemic, the Municipal Councils in collaboration with the Ministry of Local Government, have adopted this measure to provide some relief to the ratepayers," stated Minister for Local Government Premila Kumar.

In addition, from 1 August 2021, the Municipal Market Vendors have been provided stall fee waiver by the Government. A sum of \$2.6 million has been allocated to pay the market stall fees for one year ending on 31 July 2022 and this change applies to both casual and permanent vendors. This assistance will put more money in vendor's pockets.

In addition to the above initiatives, a total of \$2.5 million has been allocated by the Government to pay base fees for taxis, minibuses, carriers and buses for one year. This initiative provides much needed relief to the Public Service Vehicle (PSV) owners during these challenging times.

"The councils around the country have been urged to implement appropriate strategies to strengthen their financial positions and focus on the collection of market fees arrears and arrears in PSV fees until 31 July 2021. Strategies need to be further realised by the Councils to collect the rates arrears, which remains the major revenue stream of all the councils. There are municipal councils who are not financially healthy and are struggling to provide basic services. The Councils must develop innovative plans to strengthen the operations of the Councils by first prioritising fixed expenses. They have been encouraged to thoughtfully execute measures to become financially independent and sustainable" said Minister Kumar. -MINISTRY OF LOCAL GOVERNMENT

THE Minister for Housing and Community Development, Premila Kumar has applauded the 2021-2022 National Budget, noting it has catered for all Fijians.

Minister Kumar said that from supporting students with the continuation of TELS and Toppers program to the elderly receiving assistance, relieving Fijians through the waiver of various fees and levies and businesses receiving Government guarantee to access loans were well thought of.

"Despite hard times, my ministry is allocated a sum of \$10.94 million to provide housing support to low and middle-income earners," she said.

"The revised National Housing Policy, which was funded by the New Zealand Government is in the last phase, and will create an enabling environment for all stakeholders in the housing sec-

tor to collectively perform more effectively under improved operational and legal frameworks."

"Numerous other housing programmes and policies are being reviewed including the Assistance for Fire Victims Policy which covers all rural and maritime areas from this financial year and a 19 year old Informal Settlement Lot Allocation Policy is being finalised after a wide public consultation," she added.

She revealed that a 16-year-old Rural Housing Assistance Policy targeted towards assisting the Rural and Maritime areas was also under review for significant improvements and which is expected to bring a significant shift in rural and maritime housing.

"This will cover assistance for construction of six cyclone certified safe houses, upgrade of existing homes to meet cyclone standards and also include micro finance and micro insurance assistance," she said. "In this financial year, we have completed capital works in three settlements – Ledrusasa, Cuvu and Waidamudamu with the ministry also completing scheme plans, geo-technical reports, EIA consultations and engineering plans for six settlements – Sakoca, Tore, Tavela, Wakanisila, Caubati and Field Four."

"Topographical Survey and Scheme Plans were completed for further four projects in Nabare, Vunika, Lovu Sea Side and Tauvegavega," she added.

Minister Kumar adds that to encourage home ownership and to drive economic activities, the first home grant assistance was increased to \$30,000 per household for those earning below \$50,000.

"A total of 435 households were assisted under this programme and another 62 households under the first land purchase programme while seven of these applicants secured bank loans in excess of \$60million – resulting in almost 10-fold impact on total economic activities in construction and mortgage sectors," she relayed.

"Another 190 households are expected to benefit from the first home programme in the new financial year, with up to 100 households benefiting from the first land grant programme."

"The Public Rental Board (PRB) has cash reserves in excess of \$8 million and HART Homes with over \$0.5million will be used which have been built over time with Government assistance," she added.

Minister Kumar states that the Fijian Government continues to demonstrate its commitment towards the most vulnerable with allocation for assistance for people with special needs remaining unchanged and an increase in budget allocations for Assistance for Fire Victims and assistance for Koroipita Social Housing.

WE will look to strike the right balance between the fulfilment of our role supporting and encouraging economic activities and at the same time protecting and managing the environment well."

This is according to Minister for Infrastructure and Meteorological Services and Minister for Lands and Mineral Resources Jone Usamate while responding to the 2021-2022 National Budget in Parliament recently.

"This is a critical budget because we are being tested as a country like never before," Minister Usamate said.

"We have had natural disaster after natural disaster, coupled with the pandemic that had impacted us for over a year. We have had job losses and loss of livelihoods for a lot of our people."

Minister Usamate added that Fiji is being led by a Government that is not only resilient, but far looking and decisive.

The Ministry of Lands and Mineral Resources has been allocated a total budget of \$23.2 million, a reduction of \$1.7 million while Meteorological Services has been allocated a total amount of \$4.84 million to provide timely and quality weather, climate and hydrological information to the general public.

"The Ministry staff, under the leadership of the Permanent Secretary, are innovative to make use of this money to the best of their ability that tapping into opportunities and potential so that we can effectively and efficiently administer, develop and manage all our State land initiatives, including our country's mineral sector and groundwater resources," Minister Usamate said.

"We will continue our emphasis on supporting the development of the commercial agricultural sector and agro-processing by speeding up the process of land accessibility.' Minister Usamate said "as we approach the cyclone season, Fiji Met is gearing up and getting ready to ensure they are up to speed in weather forecasting, in hydrological assessments, forecasting of coastal inundation and also for flooding forecasts". "It is essential for our network to ensure that we have consistent weather reporting."

## **Municipalities ensure safety for all Fijians**

THE Ministry of Local Government has been allocated \$12.7 million for urban and rural planning, collection of solid wastes and overseeing the planning and development of growth centres into new towns.

Minister for Local Government, Premila Kumar, said municipal councils have implemented a number of safety measures for all Fijians since experiencing the second wave of the COVID-19 pandemic.

"The councils supported the Ministry of Health in the awareness programme with decontamination of sites and in the vaccination campaigns with eight drive-through sites set up for vaccination and swabbing - making it safer for the people to stay within their bubbles,' Minister Kumar said. "The National Fire Authority (NFA) has worked tirelessly to disinfect and decontaminate vehicles and cargo at the borders. In addition, the NFA provides ambulance service to communities in Suva, Nasinu, Nausori, Sigatoka, Ba, Labasa, Rakiraki, Lautoka, Savusavu, Navua, Korolevu and Korovou." "This service is a critical need at this point in time, hence, the funding of \$1.64 million will help the continuation of this service," she added. Minister Kumar said the Government is providing relief to all market vendors around the country with the waiver of stall fees and that an allocation of \$2.6 million will greatly reduce the operational cost and put more money in their pockets.

"The removal of the "taxi base" system and implementation of "open taxi ranks" will provide all taxi operators equal opportunity to serve the public within their zones," she said. "The Ministry will continue with the preparatory work for key capital projects - Rakiraki Bus Station, new markets in Savusavu, Levuka, Dreketi, Lami and Nakasi in the new financial year."

"The Department of Town and Country Planning has approved six major building applications from Mangrove Jacks PTE, Rups Investment PTE Limited, Interior Designs PTE Limited, Ganga PTE Limited, Fiji Ports Authority, and Aquarius Tours PTE Limited with a total value of \$37.1 million dollars since the

start of the second wave," she added.

The Attorney-General and Minister for Economy, Aiyaz Sayed-Khaiyum announced in Parliament that amendments have been made to the Town Planning General Provisions which will reduce plot ratios, building setbacks and site utilisation.

Minister Kumar said that currently only 20 per cent of the plot can be developed on an unsewered lot.

"The minimum lot sizes for unsewered Residential B lots will be reduced from 800 square meters to 600 square meters, which will allow for more lots to be created, considering shortage of land in the urban areas," she added.





Cut two pieces of cotton fabric (length of 25 cm and height of 15 cm each)



Fabrics made of thick cotton or cotton blend, like a tea towel. (If you can see the sunlight through the mask, it is too thin.)

Place the two pieces of fabric

on top of each other on a table.

Hem or stitch the edges of the two fabrics by cutting away any excess or loose fabric.



Fold the outer piece of fabric (the one touching the table) over slightly on top of the other piece. Sew the folded over piece onto the top piece. Perform this for both the top and bottom parts of the mask.



Place the four cotton threads or two elastic pieces on either side of the mask. Fold over the outer and inner pieces together on top of the threads or elastic. Sew these two sides pieces to securely hold the threads or elastic pieces in place.



**G**WE don't love rugby just because it lets us forget our troubles, we love it because it inspires us to overcome them."

This was message by Prime Minister Vorege Bainimarama after announcing million-dollar package to reward the Olympic heroes for all their sacrifice and hard work. Prime Minister Bainimarama said Fiji's first Summer Olympic Gold came amid the

ruin of Cyclone Winston in 2016. "It pulled the nation from the depths of despair to joy and celebration just as we were turning towards the more resilient Fiji that we are today. "Now we face a new adversity. For months, we've been without the comforts of our normal lives as we contend with the deadly Delta variant of COVID-19." "Seven minutes at a time, the light of Olympic greatness pierced through that darkness. With every tackle, with every try, we were reminded of what Fijians can achieve when we stand united and sacrifice for each other. And after more than a year cut-off from the world, we were reminded of our place in it - a small country capable of giant achievement." Prime Minister Bainimarama paid tribute to Fiji 7s coach Gareth Baber for his commitment, hard work and continuous perse-



of the decade, another "thank you" just doesn't feel sufficient.

"That is why we will be buying Jerry a piece of land and helping fund the construction of a home. "The game's COVID protocols kept the boys from home for four months longer than some had ever been away. By the time the Olympic Torch was lit in Tokyo, it was any nation's Gold for the taking."

Prime Minister Bainimarama announced that the Fijian government will be awarding \$33,000 each to every team member and the team management.

"There is only one person on Earth with two Rugby 7s Gold medals — he is a Fijian, and his name is Jerry Tuwai. At least, I hope he still has two. I hear he tried to gift one of his medals to Coach Baber."

"That's the humble hero we know and love. After two Golds, three world 7s series titles, and recognition as the mens' sevens player

"Watching our women compete was an experience I will never forget. But the memory of watching my granddaughter watch our Fijiana make their mark on world rugby made it much more meaningful, because I could see the inspiration in their eyes."

"They knew at that moment that they could achieve anything they set their minds to, that they could be anything they wanted to be, and I'm sure every other girl in Fiji felt that same inspiration. To see Fijian women achieve what our Fijiana achieved is the proudest moment in my lifelong rugby fandom. I'm sure every parent of daughters in Fiji feels the same."

The Fijiana team will be getting \$11,000 for each member.

मामले में गिरावट, जश्न मनाने की खबर नहीं है

स्वास्थ्य मंत्रालय के पेमनन्ट सकेटरी डाक्टर जईम्स फोन्ग का कहना है कि पिछले कुछ दिनों में कोविड-घश के मामले में हुई गिरावट की रिपोट कोई जश्न मनाने की खबर नहीं है।

उन्होंने कहा कि लोगों को गलतफैमी नहीं होनी चाहिए कि इन दोनों विभागों में सच में मामले में गिरावट हुई है। उनके अनुसार उन्होंने पिछले अपने कोविड-घश परिक्षण की रणनिति में कुछ बदलाव किया है ताकि उनके लेब और स्वास्थ्य सेवा पर बोज कम हो सके।

जाँच से पता चला है कि इन लोगों को वायरस का पहला लक्षण सुई का दूसरा डोज़ लगने से कुछ दिन पहले या बाद में सामने आया जो कि दर्शाता है कि इन लोगों को सुई लगने से पहले वायरस हो गया था।

अभी तक फीजी में किसी की मौत पूरी तरह सुई लगाने के बाद कोविड-19 की वजह से नहीं हुई है।

नए प्रकोप की वजह से वायरस फैल रहा है, हम जानते है कि सिर्फ सुई लगाना काफी नहीं है - हमें लगातार सभी स्वास्थ्य नियमों का पालन करना ज़रूरी है जो हम जानते है कि इस प्रकोप के खिलाफ काम करेगा - जैसे कि मास्क पहनना, हाथ धोते रहना और उन लोगों से दूरियाँ बनाए रखना जो आपके परिवार से नहीं है। हम अपने अस्सी प्रतिशत लोगों को पूरी तरह से सुई लगाने वाले लक्ष्य से अभी भी दूर है इसीलिए यह नियम बहुत ज़रूरी है जबकि लोगों को सुई लगाने वाले अभियान में सुधार हो रहा है।

हमारे समाज में जिन लोगों ने अभी सुई नहीं लगवाडे है. से फिर याद दिलाडे जा रही है कि वे सच्चाई सुने और समाज में फैली गलत जानकारी और अफवाहों को न माने। जो फैसले आप लेते है वो न केवल आपपर असर करता है बल्कि आपके परिवार के सदस्य, समाज और देश पर असर करता है। डाक्टर फोन्ग सभी को याद दिला रहे है फिर चाहे उन्हें सुई लगी है या नहीं कि वे अपने स्वास्थ्य का ध्यान रखें और कोविड-19 के लक्षण दिखने पर तुरन्त अपने आप को अलग कर ले। उन्होंने कहा कि रोकथाम वाले इलाके हटाने और केफ्यू के घण्टों में बदलाव पर तबही विचार किया जाएगा जब देखा जाऐगा कि समाज में कितने लोगों को सुई लगी है।



# स्कूल्स अगले कुछ महिनों में नहीं खुलेंगे: ए-जी

अर्थव्यवस्था मंत्री अईयाज़ सैयद खैयुम का कहना है कि ट्रान्सपोर्ट असीसटन्स को 2021/2022 राष्ट्रीय बजट से \$4.3 मिलीयन से घटाया गया है क्योंकि उन्हें उम्मीद है कि अगले कुछ महिनों में स्कूल फिर से नहीं खुलेंगे। ओपरैटिग ग्रन्टस में गिरावट को लेकर संसद में सवाल उठने के बाद अर्थव्यवस्था मंत्री मान्नीय अईयाज़ सैयद खैयुम ने इसपर प्रकाश डाला। मंत्रालय कैसे छात्रों के लिय काउन्सेलिग प्रदान करेगा जब वे वापस स्कूल जाएगे पर सवाल भी उठाए गए क्योंकि पहले स्टूडंट कौंसिलर्स ओर स्कूल पुरोहित के लिय एलोकेशन

दिए गऐ थे। विपक्ष का कहना है कि शिक्षक ऐसा करने के काबिल नहीं हैं। जवाब देते हुए, शिक्षा मंत्री रोज़ी अक्बर ने कहा कि शिक्षक प्रशिक्षण के साथ या प्रशिक्षण के बिना सबसे अच्छे कौंसिलर्स होते है क्योंकि उनके पास छात्रो से साथ सबका अच्छा अनुभव रहेता है।हालाकि उनके पास प्रशिक्षित परामर्शदाता है जो हाल ही ग्रेजूएट हुए है और उन्हे डिवीज़नों में भेजा गया है। उन्होंने कहा कि इसीलिय वे अब कौंसिलिंग में स्कोलाशिप प्रदान कर रहे हैं। मंत्री अक्बर ने कहा कि वे छात्रों के माता पिता के साथ लगातार संर्पक में है ताकि बच्चों को इन कठिन समय में नज़र अंदाजन किया जाए।

## पिछले साल से अभी तक चार लाख से ज़्यादा बीज के पेक्स बाँटे गए

सहायक कृषि मंत्री विएम पिल्ले का कहना है मंत्राल य ने अभी तक चार लाख सत्तर हजार बीज पेक्स घरों तक बाँटे है जबसे यह प्रकोप पिछले साल शुरू हुआ है। 2021/2022 राष्ट्रीय बजट के सहयोग में बात करते हुए उन्होने कहा कि इस साल अप्रेल में इस गतिविधि को तेज़ कर दिया था, जहा सिर्फ तीन महिनों में, मंत्रालय 27,000 बीज पेकज बाँटने में कामयाम रही।2020-2021 के आर्थिक साल के दौरान मंत्रालय ने अपनी नियोजित गतिविधियों का विस्तार करना जारी रखा और महामारी के प्रभाव को कम करने के लिय कई पहल की और विविध पौष्टिक सम्रद्ध खाध पदार्थी तक सीधी पहुँच सुनिश्चित करके, भोजन पर बचत से बिजली को बढ़ाकर कई कमजोरियो को कम किया जा सकता है, महत्वपूर्ण खाध उत्पादों और रोजगार के अवसरों के लिय एक विकल्प प्रदान करना जरूरी है। सहायक मंत्री ने केश फो कलटीवेशन पहल पर भी प्रकाश डाला जिस्से फि जी के एक हजार किसानों को प्रति किसान दो सौ डालर मिला है। उन्होंने कहा कि अगले फैस में तीन हजार किसानों को सहायता दी जाएगी। सहायक मंत्री पिल्य ने कहा कि इस सहायता से किसान, एक एकड़ की जमीन खरिदने और उसे खेती करने के लिय सक्षम बनाने के लिय तैयार करना पड़ेगा जिसके लिय कुल \$800,000 वितरित किए जाएगे। पिछले साल फिजी डै सामारोह में मंत्रालय ने फलों वाले पेड़ पहल की अयजना की, जहाँ पचास गाँव वालो की पहचान की गई उन्हें अपने समुदायों के आसपास पौधे लगाने के लिय पचास फलो के पौधे दिए गए। उन्होंने कहा कि इस कार्यकम से उन्हे सफलता मिली जिसके कारण पूरे गावों और फिजी के समुदायों में इस पहल को इस वि त्तीय वर्ष में जारी रखेंगे। उन्होंने कहा कि वह उस बजट के इरादे का समर्थन करते हैं जो कोविड के लिए मंत्रालय की प्रतिक्रियाओं को बढ़ावा देता है और एक बार फिर खाध सुरक्षा के महात्व, स्थानीय रूप से उगाए गए फलों और सब्जियों को बढ़ावा देने और आयातित भोजन पर निर्भरता को सीमित करता है।







आबादी को नवंबर से पहले सुई नहीं लगी-मंत्री कोया


कोमर्स, ट्रेड, टुरिज़म और ट्रान्सपोर्ट मंत्री फैयाज़ कोया का कहना है कि अगर हम इस साल नवंबर तक हमारी आबादी के अस्सी प्रतिशत लोगो को सुई नहीं लगाते, हम दुनिया के उन देशों में से होगें जिन्हें अन्य देश जाने पर प्रतिबन्ध रहेगा। मंत्री कोया ने कहा कि इस बजट के माध्यम से वे ऐसी पहल ला रहे है जो टुरिज़म व्यवसाय को दोबारा शुरू करना महात्वपुर्ण है। उन्होंने कहा कि वैश्विक संकट खत्म होने से बहुत दूर है जबकि जीवित रहना अभी भी हमारे दिमाग में सबसे उपर है, इन सुई के ज़रिय हमें आशा की कीरण दिख रही है।

मंत्री कोया ने कहा कि कुछ ऐसे देश हैं जिन्हे दो हजार तेईस तक सुई की प्राप्ती नहीं होगी। उन्होंने कहा कि जब तक वे देश अन्य देशों से अलग आईसोलेशन में रहेंगे तब तक फिजी में दुरिज़म व्यवसाय ठीक नहीं होगा और हम ऐसा होने नहीं दे सकते। उनका कहना है कि अच्छी खबर यह है कि हमारे पास अपनी योग्य आबादी के लिय पर्याप्त सुई है और टुरिज़म व्यवसाय को फिर से खोलने के लिय तीन स्तरीय द्रष्टिकोण तैयार है। मंत्री कोया ने एक बार फिर दोहराया कि उन्होंने अन्य व्यवसाय को खोल दिया है क्यों कि यह उन्हें बंद करने का समय नहीं है जिस्से हजारों फिजीवासियों के लिय काम नहीं है।

उन्होंने कहा कि स्वास्थ्य और सुरक्षा ज़रूरी है इसीलिय स्वास्थ्य मंत्रालय के साथ संयुक्त रूप से मंजुरी और परमिट दिए जा रहे हैं। उन्होंने कहा कि खतरा तो रहेगा लेकिन उपायों से इन खतरों को कम किया जा सकता है। मंत्री कोया ने कहा कि 2021/20 22 राष्ट्रीय बजट व्यवसायों और फिजीवासियों को संशक्त बनाने के लिय तैयार किया गया है। उन्होंने कहा कि विपक्ष ने एक बार फिर गलत जानकारी फैलाई और फिजीवासियों को उकसा रहे हैं जो कि गलत है। मंत्री कोया ने कहा कि ई-टौकी लेंड ट्रस्ट एक्ट से संशोधन के बदलाव से जमीन मालिकों से कोई अधिकार नहीं छीना जा रहा है, बल्कि सेवा वितरण में और तेजी लाई जाएगी।

अटेनी जेनरल तथा अर्थ-व्यवस्था मंत्री, अईयाज़ सईयद खईयूम ने इतउकेई लेन्ड ट्रस्ट एक्ट 1940 की धारा बारह को लेकर स्पष्टीकरण दिया है। उन्होने कहा कि इतउकेई लेन्ड ट्रस्ट एक्ट 1940 की धारा बारह वर्तमान में ज़मीन लीस पर लेने वाले और अन्य तीसरे व्यक्ति को इतउकेई लेन्ड ट्रन्ट बोर्ड ("TLTB") से मंजूरी लेने की ज़रूरत नहीं है अगर वे नीचे दी गई सूची में से कुछ करना चाहते है जिनमें:

ईतउकई लेन्ड ट्रस्ट (बजट में बदलाव) वाला बिल 2021एक्ट की धारा बारह के तहत कुछ प्रस्तावित बदलाव करना चाहता है: इतउकेई लेन्ड ट्रस्ट (बजट में बदलाव) का बिल 2021 एक्ट कीधारा बारह में कुछ प्रस्तावित बदलाव करना चाहता है: 🔳 12(1) जैसा कि कानून के अंतरगत हो सकता है, इस एक्ट के नीचे, ज़मीन लीस पर लेने वाला कोई व्यक्ति, बोर्ड, जो एक लेसा है या हेड लेसा या जिससे ज़मीन पहले ली गई है की स्वीकृति बिना ज़मीन को छीन नहीं सकता न उनका सौदा कर सकता है, चाहे वो यह इसे बेचकर, द्रान्सफा या सब लीस करके या किसी और तरीके से। कोई भी सहमति देना या रोकना पूरी तरह से बोर्ड का अधिकार है और इनकी सहमति बिना कोई बिकरी, ट्रान्सफ से छीनना या सौदाक को कानुनी रूप से ई मान्यता नहीं मिलेगी। संयह बिल प्रस्ताव रख है कि लीस पर ली गई ीन को गिरवी रखने, चार्ज

करने, ज़मानत पर रखने, केवियट या अदालत के द्रारा कोई भी प्रकिृया से पहले टी एलटी बी से मंजूरी लेने की ज़रूरत नहीं है।

इसके अलावा जहाँ अन्य सौदे के लिए टी एल टी बी से मंजूरी लेने की ज़रूरत है वहाँ टी एल टी बी मंजूरी देने से मना कर सक ता है अगर लीस के शर्त तोड़े गए या अज़ी कानून के तहत नहीं लगाया गया है। इस बात पर ज़ोर देने की ज़रूरत है कि बिल के तहत सिफउन्हीं लीसस पर टी एल टी बी से मंजूरी लेने की ज़रूरत नहीं है जिन्हें टी एल टी बी ने उचित प्रकार से सौपा है और वो रिजिस्ट्रार ओफ टाएटल्स के नीचेरेजिस्टड है। रेजिस्टड लीसस सिर्फ टी एल टी बी प्रदान करता है जब ईतउ कई ज़मीन मालिकों की युनिट्स उन्हें ज़रूरी सहमति दे देते है और जब उचित लीस समझौते में शर्त जैसे किरायाऔर प्रिमियम निर्धारित हो जाते है। यह बिल वाकावनुआ और रोज़गारी के लिए अन्य व्यवस्थाओं पर लागू नहीं होते है जो कानून के तहत अच्छी तरह से रेजिस्टा नहीं हुए है।

इसके अलावा जैसे 2021-2022 सालाना बजट में घोषणा की गई है, लीस पर दी गई किसी सरकारी या ईतउकई ज़मीन पर पानी या बिजली की व्यवस्था

करने के लिए मंजूरी की ज़रूरत नहीं है। उन्होंने फिर से ज़ेर दिया कि यह केवल रेजिस्टड लीस पर लागू होते है। इसी तरह का बदलाव सभी सरकारी ज़मीनों के लिए स्टेट लेन्ड्स के तहत श्वजट में बदलावत्त बिल टज्ञटघ में प्रस्तावित रखा गया है जिसके नीचे डायरेक्टा ओफ लेन्ड्स से मंजूरी की जरूरत नहीं होगी

अगर कोई गिरवी, चार्ज, ज़मानत, केवियट या कोई अदालती कार्यवाई की गई। बेशक टी एल टी बी में नितियों को लेकर मंजूरी लेने में जो देरी होती है और इसके साथ जो कानूनी खर्च जुड़ा हुआ है के कारण ईतउकई ज़मीन के बहेतर उपयोग और पुँजी लगाने में भी बाधा पहुँची है। गिरवी रखनेऔर केवियट के लिए मंजुरी हटाने से ईतउकई ज़मीन की लीसस बाज़ार में और भी आकर्षक हो गई है जिससे ईतउकई ज़मीन मालिकों को और भी भारी फायदा होगा।

''कुछ लोग बहस कर रहे है कि मंजूरी की प्रोसेसिंग फी के रूप में टी एल टी बी की आमदनी कम होगी। लेकिन अगर धारा बारह में बदलाव हुआ तो इसका विपरीत होगा जहाँ टी एल टी बी का कुशल व्यापार और सेवा उन्हें और भी लाभ होगा, क्योंकि ज़मीन लीस पर लेने वाले अपनी ज़मीन में और पैसे लगा एंगे जिससे बाज़ार में ईतउकेई ज़मीन की कीमत बढ़ेगी और किराया बढ़ेगा और ज़मीन मालिको को भी ज़्यादा पैसे मिलेंगे। आमदनी कमाने के लिए केवल मंजूरी की फीस पर ध्यान नहीं देना चाहिए बल्कि मार्केट लीस प्रिमियम और इंडिपेंडन्ट वेलुएयस दारा रेंटल पर असेस करने पर भी गौर करना चाहिए। लम्बे समय की रणनिति इस बारे में होनी चाहिए कि हम कैसे ज़मीन मालिकों को और शक्ति कैसे दी जाए जो फीजी में सभी ज़मीनों के इक्यान्बे 91 प्रतिशत ज़मीनों के मालिक है कि वे और अमीर हो, उनकी ज़मीन की कीमत उपर जाए जो बाज़ार में बेची जा सके तथा वे फीजी की अर्थ-व्यवस्था में योगदान दे सके," अटेनी जेनरल ने कहा। कुछ नितियाँ हटाने से टी एल टी बी इक्कीसवी (21st) सदी में चला जाए और संस्था को और भी कार्यकुशलबनाऐगा, ईतउकई जमीन की कीमत बढाने में मदद करेगा, जमीन के सौदे होंगे तथा ज़मीन मालिक और भी अमीर होंगे। ऐसा प्रतीत हो रहा है कि जो लोग इस बदलाव के खिलाफ है ने बदलाव के बारे में पढा नहीं है या फिर ये समझा नहीं है कि उनपर इस का कानूनी असर कैसा होगा।




