INDUSTRY EMBLEM ACT 2011

Industry Emblem (Forms and Fees) (Amendment) Regulations 2018

In exercise of the powers conferred on me by section 12 of the Industry Emblem Act 2011, I hereby make these Regulations—

Short title and commencement

1.—(1) These Regulations may be cited as the Industry Emblem (Forms and Fees) (Amendment) Regulations 2018.

(2) These Regulations come into force on the date of publication in the Gazette.

(3) In these Regulations, the Industry Emblem (Forms and Fees) Regulations 2011 is referred to as the “Principal Regulations”.

Schedule 1 amended

2. Schedule 1 to the Principal Regulations is amended by—

(a) in Part B in items 1 to 4 of column 2 of the table after “ Fijian Packed/ Assembled/Designed”, inserting “ Fijian Organic”; and

(b) deleting Part C and substituting the following—

“PART C	PAYMENT DETAILS
----------------	------------------------

Fees Payable

(1) The annual licence fee for an application for the use of any of the emblems set out in the Schedule to the Act or Schedule 3 to these Regulations is \$45.87 VEP for a company or an individual.

(2) A micro enterprise and small enterprise as defined under the Small and Micro Enterprises Development Act 2002 are exempt from paying the annual licence fee for an application for the use of any of the emblems set out in the Schedule to the Act or Schedule 3 to these Regulations.

Schedule 2 amended

3. The Principal Regulations is amended by deleting Schedule 2 and substituting the following—

“SCHEDULE 2
(Regulation 2(2))

FEES

- (1) The annual licence fee for an application for the use of any of the emblems set out in the Schedule to the Act or Schedule 3 to these Regulations is \$45.87 VEP for a company or an individual.
- (2) A micro enterprise and small enterprise as defined under the Small and Micro Enterprises Development Act 2002 are exempt from paying the annual licence fee for an application for the use of any of the emblems set out in the Schedule to the Act or Schedule 3 of these Regulations.”.

Schedule 3 amended

4. Schedule 3 to the Principal Regulations is amended by—

(a) after paragraph 2(f) inserting the following new paragraph—

“(g) **“Fijian Organic”**

- (i) All produce or products grown or processed in Fiji are to be certified with the Pacific Organic Guarantee Scheme standards or any international standard.”; and

(b) in paragraph 4—

(i) deleting the first sentence and substituting the following—

“There are 9 representations of the emblem as illustrated below.”; and

(ii) inserting the following new emblem in addition to the existing emblems—
